Current Status on Legislation and the DoH National OD Policy Framework

The Patient Safety Bill was discussed and passed Committee Stage at the Health Committee on 10th March 2022. This legislation remains a priority for the Minster for Health.

The Draft National Open Disclosure Policy Framework: The National Open Disclosure Office and Steering Committee have provided feedback on the framework.

Open Disclosure Training Uptake:

Quarter 3 training statistics have demonstrated a significant increase in the uptake of both e-learning and face to face training with 26,735 completions of the online training programmes across all service areas during this quarter. Open Disclosure: Information Leaflet for Staff

HSE Open Disclosure Themed Week

7th to 13th November, 2022



What is Open Disclosure? Open disclosure is defined as an open, consistent, compassionate and timely approach to communicating with patients and, where appropriate, their relevant person following patient safety incidents. It includes expressing regret for what has happened, keeping the patient informed and providing reassurance in relation to on-going care and treatment, learning and the steps being taken by the health services provider to try to prevent a recurrence of the incident (HSE Open Disclosure Week 2019).

Patient safety Incidents:

Patient safety incidents include harm, no harm and near miss incidents.

Ethos of Open Disclosure: Open disclosure is HSE Policy. It is a core professional requirement anchored in professional ethics. We must communicate effectively with our patients/service users in a compassionate, empathic and thoughtful manner at all times and especially following patient safety incidents.

Our Responsibilities in relation to Open Disclosure

Following a patient safety incident it is important to discuss what has happened with the patient/service user as soon as possible to:

- acknowledge what has happened and the impact;
- say you are sorry;
- · provide the facts available;
- answer questions factually;
- provide reassurance about on-going care and treatment and
- provide reassurance about actions being taken to try to prevent the incident happening again.

Open disclosure may involve meeting with the patient on one or more occasions depending on the level of harm that occurred.

Where can I get support if I have been involved in a patient safety incident? Support is available from:

How should I document Open Disclosure?

A record of all open disclosure discussions must be maintained. The salient points of the open disclosure discussion, including the details of the apology provided, must be documented in the patient/service user's clinical/care record.

Formal Open Disclosure meetings:

A written record of the meeting must be provided to the patient/relevant person after the meeting including the salient points discussed, details of the apology provided, actions agreed and the name and contact details of the designated person (key contact person). A copy of this record will be maintained on file by the health services provider.

National Incident Management System (NIMS): The patient safety incident must be reported on NIMS and the Open Disclosure fields on NIMS must be completed.

Open Disclosure Mandatory Training

Open Disclosure training is mandatory for all staff with a requirement to complete refresher training every 3 years.

All staff must complete Module 1 on HseLanD
"Communicating effectively through Open
Disclosure"

All staff who, as part of their role, may have to engage in formal Open Disclosure meetings must also complete

Module 2 on HseLanD "Open Disclosure: Applying Principles to Practice" and

the 3 hour practical Face to Face skills workshop.
