* To ask the Minister for Health to provide a breakdown of the total of section 38 and section 39 funding for each of the ten Regional Drug and Alcohol Task Forces and each of the 14 Local Drug and Alcohol Task Forces here in each of the years 2010 to 2016 to date; and if he will make a statement on the matter.

Dear Deputy O'Brien,

The Health Service Executive has been requested to reply directly to your above Parliamentary Question which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position:

Response to PQ 19219/16 identifies Drug and Alcohol Task Force Global Allocations for 2014, 2015 and 2016. HSE Section 39 funding is aligned to HSE Community Health Organisations (CHOs) rather than Drug and Alcohol Task Force (DATF) geographical areas.

Table 1 outlines HSE Section 39 funding attributed to addiction services for each CHO.
