* To ask the Minister for Health the facilities for drug and alcohol rehabilitation that are available for long term in-patient care; and if he will make a statement on the matter.

Dear Deputy O'Reilly,

The Health Service Executive has been requested to reply directly to your above Parliamentary Question which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position:

Residential Tier 4 Treatment and Rehabilitation services provide treatment episodes of varying lengths of duration. Detoxification can range from 10 to 56 day treatments, Short Stay can range from 28-42 days, Long Stay can range from 6 weeks to 6 months, Therapeutic Communities can range from 14 weeks to 8 months, and Step Down services can range from 12 weeks to 12 months. Tier 4 funding currently allocated under addiction, provided directly by the HSE or agencies that are in receipt of funding from the HSE are as follows:
