To ask the Minister for Health if details will be provided of active addiction support services and the funding allocated to each in 2019, 2020 and to date in 2021, in tabular form.

Dear Deputy Clarke,

The Health Service Executive has been requested to reply directly to your above Parliamentary Question which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position:

The appendix table outlines the total expenditure for 2019 and allocation for 2020 attributed to HSE Addiction Services, HSE Section 39 funding, per Community Health Organisation (CHO) Areas and the National Drug Treatment Centre.

For the Deputy's information an additional €8.35 million funding has been made available for the HSE's National Service Plan for 2021. This will further enhance the provision of addiction services nationally further details of which are not available by CHO at this time.

In addition, other areas of the HSE provide services to clients with addiction problems including Primary Care Reimbursement Service, Health and Wellbeing, Mental Health, Acute Hospitals Services and Emergency Departments and Primary Care that are attributable to drugs programmes and the objectives of the National Drug Strategy.
