To ask the Minister for Health to outline the drug rehabilitation and addiction services available in Louth, including the number of centres in the country, a detailed list of services provided, the number of patients served, and the current waiting lists; and to provide a breakdown of waiting lists per CHO area, in each of the years 2020 to 2024, in tabular form.

Dear Deputy McGreehan,

The Health Service Executive have been requested to reply directly to your above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position:

An analysis of the data provided in treatment services within the National Drugs Treatment Reporting System (NDTRS) (see information about the <u>NDTRS</u>) includes all cases treated for problem use of drugs as a main problem in 2023 (the most recent year available). The analysis includes cases treated for problem drug use (as a main problem) in treatment services in Ireland in 2023. Cases treated in general practitioners (GP) and prison services have been excluded from this analysis.

There were 12,266 cases treated for problem drug use nationally in 2023. Of these cases;

- 253 cases residing in Louth (in the 30 days prior to treatment) were treated in services based in Louth.
- 326 cases residing in Louth (in the 30 days prior to treatment) were treated in any service (regardless of location of service but also including Louth).
 - o 73 cases who resided in Louth were treated outside Louth.
- 329 cases were treated by service providers based in Louth (regardless of where case resided but does include the 253 cases residing in Louth).

Services providing treatment:

The total number of services in 2023 recording cases for drug addiction treatment was 434. Of these 7 were located in Louth (Table 1)

It is not possible to provide a full breakdown of addiction service waiting lists per HSE Region, as outside of residential and Opioid Agonist Treatment, they are not routinely recorded.
