## PQ 59403/25

To ask the Minister for Health for the capacity and location of all public in-patient specific addiction treatment centres currently available in the State; and if she will make a statement on the matter.

Dear Deputy Connolly,

The Health Service Executive have been requested to reply directly to your above Parliamentary Question which you submitted to the Minister for Health for response.

Table 1 below lists the number of beds available as at November 2025 in residential addiction services provided directly by the HSE or Agencies that are in receipt of funding from the HSE, by County.

While the HSE can provide funding to services as a whole, in the main, the HSE purchases treatment episodes rather than beds. The duration of the treatment episode is a determination as to capacity of a 'bed space', which is dependent on the different treatment type and the length of the programme that a particular service runs. Note access to all beds is based on need rather than geographical location.
