## Re: 9606/25

To ask the Minister for Health the average wait time by facility from referral to admission for addiction rehabilitation and detox; and if she will make a statement on the matter. -Ann Graves

Dear Deputy Graves,

The Health Service Executive have been requested to reply directly to your above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position:

An analysis of the data provided in treatment services within the National Drugs Treatment Reporting System (NDTRS) (see information about the <u>NDTRS</u>) includes all cases treated for problem use of drugs as a main problem in 2023 (the most recent year available). **Wait time** is calculated here as the number of days between date referred for treatment and date treatment commenced. Addiction treatment services may have different entry policies; therefore, data may not be directly comparable and should be interpreted with caution.

Under Action 5.1.47 of the National Drugs Strategy 2017-2025 all publicly funded drug and alcohol services are required to return data to the NDTRS. The analysis includes cases treated for problem alcohol or other drugs use as a main problem in residential treatment services in Ireland in 2023. This includes cases treated in residential detoxification services and those who received a detox in a residential service. Cases treated in non-residential settings such as outpatient services, low threshold services, general practitioners (GP) and prison services have been excluded from this analysis. The figures reflect assessments and entries into treatment in 2023 (new cases and previously treated cases returning to treatment) and do not include the number of cases continuing in treatment from preceding years. It is not possible to distinguish between step-down and other types of treatment provided in residential services within the NDTRS.

Once the exclusion criteria as outlined above were applied, 4,540 cases were treated in residential addiction rehabilitation and detox services in 2023. Of these 647 cases were treated in specialised inpatient detoxification services (Table 1).

In 2023, the median wait time to treatment for all cases treated in residential services was 18 days. This indicates that half of cases waited less than 18 days and half waited more than 18 days for treatment (Table 2).

Wait time for treatment varied across service providers. The median wait time (days) for treatment in 2023, for individual residential addiction services is outlined below (Table 3).
