To ask the Minister for Health the number of detoxification and rehabilitation treatment beds by region in each of the years 2010 to 2019 and to date in 2020, in tabular form.

Dear Deputy Gould,

The Health Service Executive has been requested to reply directly to your above Parliamentary Question which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position:

In relation to detoxification Table 1 outlines the location and number of beds available in medical and community based residential detoxification Units between 2010 and to date in 2020.

A count of residential/ step down beds is taken at a point in time as there are a number of residential providers that obtain funding for beds beyond the HSE. The current National Drugs Strategy "Reducing Harm, Supporting Recovery A health-led response to drug and alcohol use in Ireland 2017-2025" identifies that since 2007 the number of residential beds has increased significantly, largely due to the increased provision of beds in community-based residential facilities. Additional HSE funding over the past number of years has resulted in an increased number of residential addiction beds providing treatment and aftercare services. As of the end of 2018, the HSE estimated 793 residential beds, comprising 19 inpatient unit detoxification beds, 127 community-based residential detoxification beds, 4 adolescent residential detoxification beds, 625 residential rehabilitation beds and 18 adolescent residential beds.

From the deputy's information Table 2 provides the most recent scoping exercise of residential rehabilitation and step down services provided directly by the HSE or Agencies that are in receipt of funding from the HSE, by Community Health Organisation (CHO) Area. The table highlights have reduced bed capacity to operate within public health guidelines. Note access to all beds is based on need rather than geographical location.
