Introduction

A key objective of the Enterprise Risk Management (ERM) programme is to develop and deliver training to support the implementation of the <u>HSE's ERM Policy 2023</u> and the building of the HSE's capacity and capability to effectively embed an enterprise approach to risk management at all levels in the HSE.

- Training is tailored to the role of staff with responsibility to identify, manage and report on risk across operational, strategic and clinical levels of the HSE.
- Training has been developed to recognise the importance of risk management from both the bottom-up and the top-down to ensure an enterprise approach to risk management is embedded in the HSE.
- Training as a learning journey will include continuous learning that takes place over a period of time and includes digital learning (HSELanD), workshops, and Train the Trainer approaches. The aim of a learning journey is to help develop necessary new capabilities and competencies effectively.

Module 2: The Fundamentals of Enterprise Risk Management

Aim

This programme will support the learner in understanding each of the steps in the risk management process. This course is for all HSE staff who have a role in risk management and have completed the ERM Introductory Module available; Module 1: ERM Introduction

Learning Outcomes

Upon completing this programme you will be able to;

- 1. Understand the importance of establishing the context, scope and criteria for risk management, considering internal and external factors influencing the organisation.
- 2. Recognise and document potential risks relevant to achieving your objectives.
- 3. Describe a risk using Event, Cause and Impact format.
- 4. Rate a risk using the HSE's Impact and Likelihood criteria.
- 5. Recognise and document controls and actions.
- 6. Evaluate identified risks.
- 7. Identify measures to treat risks.
- 8. Understand the difference between risk communication, notification and escalation.
- 9. Understand effective monitoring mechanisms to track risks and conduct regular review of the risk register.

Module 3 Overview of key changes to the HSE Enterprise Risk Management Policy and Procedures

Aim

This programme provides a 'train the trainer' approach to delivering the key updates to the Enterprise Risk Management Policy and Procedures 2023. It was developed subsequent to the launch of the HSE's Enterprise Risk Management Policy. These sessions are hosted each month online and include a 20 minute Questions and Answers session facilitated by an ERM Senior Manager. The presentation slides and speaking notes are provided to all attendees afterwards to assist with delivering training to their colleagues.
