People who have documentary evidence of a complete COVID-19 vaccination course with a COVID-19 vaccine authorised by the

- EMA
- FDA
- MHRA or
- · recommended by WHO

Should be considered fully vaccinated if they are resident in Ireland.

Primary Course for Adults

Adults who have documented evidence of the required doses of one of the below authorised vaccines should be considered to have completed their primary course or booster COVID-19 vaccination if they are resident in Ireland.

Primary Course for Children

Children who have documented evidence of the required doses of one of the below authorised vaccines should be considered to have completed their primary course COVID-19 vaccination if they are resident in Ireland.

Comirnaty® 10mcg Original Children aged 5 years to 11 years	2
Comirnaty® 10mcg BA4-5 Children aged 5 years to 11 years	2
SpikeVax® 50mcg Children aged 6 years to 11 years	2
Comirnaty® 25mcg Children aged 6 months to 5 years	2

Booster Dose for Children

Partially complete

Offer 1 EMA authorised COVID-19 vaccine to complete the vaccine course.

The minimum interval between the last vaccine dose and an EMA authorised COVID-19 vaccine is 28 days.

Vaccines not authorised

The Sinopharm/WIPB COVID-19 vaccine, Sputnik V (Gamaleya), EpiVacCorona, Sputnik light, COVIVAC, Covifenz, MVC-cov1901(Medigen), Abdala, CorbeVax, ZifiVax, COVIran Barekat, QAZCOVID-IN, KConVac, Minihai, SCB2019 and Soberana02, Soberance plus, Noora, CoVLP, Sinopharm CNBG, FAKHRAVAC, Turkovac(RAZI Cov Pars), Zydus Cadila(ZyCoV-D), COVAX-19(Cinagen), WalVax, Incovacc, GEMOCOVAC, V-01, IndoVac COVID-19 are **not** currently WHO approved.

Anyone who has received these vaccines should be offered a complete course of and EMA approved vaccine.
