# Position Paper for the Provision of Influenza Vaccination for Section 39s and other healthcare organisations

## 1. Background

Healthcare workers (HCWs) prevent the spread of flu and save lives by getting the flu vaccine. The best way to protect the worker, their family and their patients is to get vaccine each year. HCWs can pass the flu virus to somebody they care for even before they know that they are sick.

The HSE Peer Vaccination Programme has been in place since 2016 in order to support the increased availability of and knowledge about the vaccine locally in healthcare environments. **In addition, HCWs can now access free vaccination through their local pharmacy and GPs.** Since 2022, the seasonal influenza vaccination programme was expanded to enable HSE nurse and midwife vaccinators to administer the seasonal influenza vaccine under medicine protocol to vaccine recipients including healthcare workers.

Seasonal Influenza Vaccination programme education: The Office of Nursing and Midwifery Services Director (ONMSD) develops the HSELanD education programme titled *Seasonal Influenza Vaccination Programme: Education Programme for Nurses and Midwives*.

A supportive document for this programme has been developed by the HSE – "Seasonal Influenza Vaccination Programme Supportive Document for HSE Vaccinators" '. This refers to registered nurses and midwives employed by the HSE vaccinating vaccine recipients including Healthcare workers'. HCWs from Section 39's and other organisations are outside the scope of this supportive information document as they are not HSE employed.

HSE nurse and midwife vaccinators and Occupational Health Services provide influenza vaccine to HSE HCWs, agency and contract staff working in HSE organisations. Due to resources, it is not possible for HCWs from other organisations to be accommodated within the HSE clinics.

To ensure widespread HCW vaccination it is recommended that all healthcare organisations provide local peer vaccination. Section 39s and other organisations have historically arranged their own influenza vaccination through an Occupational Health provider. Staff from some section 39s and other organisations have previously accessed training from the HSE and have developed Seasonal Influenza Vaccination programmes within their own organisations.

#### 2. Training as Vaccinators and Setting up Vaccinator Clinics

Management from Section 39's and other organisations must make the decision regarding the implementation of the Seasonal Influenza Vaccination programme within their own organisations and must provide governance for the programme within their own organisation. Medical oversight should be provided by the Section 39s and other organisations and not the HSE. Each organisation must confirm appropriate clinical indemnity with their own insurance provider.

Management from Section 39's and other organisations must ensure:

#### Note: The following is the education criteria for HSE registered nurse and midwife vaccinators: The registered nurse or registered midwife must have completed all of the following:

- 1. Be a Registered Nurse or Registered Midwife, on the active register maintained by the NMBI
- 2. Education programme for registered nurses and registered midwives on the *Seasonal Influenza Vaccination Programme: Education Programme for Nurses and Midwives* and any updates for nurses and midwives accessible on <u>www.HSELanD.ie</u>
- 3. An approved *Basic Life Support for Health Care Providers Course* within the last two years (i.e. Irish Heart Foundation (IHF))
- 4. Initial National Anaphylaxis Education Programme for Health Care Professionals accessible on <u>www.HSELanD.ie</u> followed by a two hour classroom based skills workshop. Recertification is required every two years by completing the on-line National Anaphylaxis Education Programme for Health Care Professionals accessible on <u>www.HSELanD.ie</u>

The HSE medicine protocols can be adopted for use in Section 39 organisations, with local governance for the medicine protocols clearly outlined. These are:

It is the organisations responsibility to ensure they are fully equipped with all equipment and resources required for the safe provision of a seasonal influenza vaccination programme, in line with the Seasonal Influenza Vaccination Programme Supportive Document for HSE Vaccinators.

#### 3. Recording vaccination

All sites administering flu vaccines (that were delivered by the HSE National Cold Chain Service i.e. not privately purchased) will use the ICT system COVAX for capturing immunisation records for flu vaccines. All vaccinators within Section 39 or Private Healthcare facility will need to use the Community Vax Portal to send the data into COVAX. Please contact the National Immunisation office (immunisation@hse.ie) if you need access to the Community Vax Portal.

### 4. National Cold Chain Service

The influenza vaccine will be provided by the National Cold Chain Service – management and storage of these vaccines are the responsibility of the Section 39's and other organisations. Any service wanting to implement a seasonal influenza vaccination programme for the first time is required to register with the National Cold Chain Service as soon as possible. Confirmation must be given that vaccines will be managed within the cold chain and a named doctor or pharmacist is required to sign the Bona Fides form.
