Hepatitis B and pneumococcal conjugate vaccines (PCV)


Remember you will need to order vaccines for the old and new schedules (5 in 1 and 6 in 1) as well as extra PCV for the catch-up.

The Customer Services Department in United Drug are taking your order for flu and pneumococcal polysaccharide vaccine (Pneumovax) this month and all sites will receive part of their order by the end of September.

This year all sites will receive deliveries of flu and other vaccines every fortnight for the duration of the flu season. You should have received details of the delivery schedule from United Drug. Please contact the Customer Services Department if you have any queries.

Don't forget Influenza vaccine is now recommended for all persons aged 50 and over!



New information booklets, posters and leaflets will be sent to you shortly.

As this year's vaccine is different from last year you should dispose of any influenza vaccine that might be in your fridge. Please return unused vaccines in their original packaging to the National Cold Chain delivery service.

Pneumococcal Polysaccharide Vaccine (PPV 23)

There is no change to the recommended age group for this vaccine all those aged 65 and over, at risk adults and children over 2 years of age.

Revaccination is not normally required. Please see the information booklet for more details

6 in 1 - Infanrix hexa

New 6 in 1 vaccine is now available in packs of 10. Remember you will need to order increasing amounts of this as more children start the new schedule.

The DTaP-HBV-IPV component of the vaccine is a white suspension and the Hib component is a white powder.

The 6 in 1 vaccine must be reconstituted in the following way

- Attach the 25-gauge needle to the pre-filled syringe.
- Transfer the syringe's liquid suspension to the vial containing the Hib pellet.
- Shake the vial well to ensure the Hib pellet is completely dissolved.
- Draw the reconstituted vaccine back into the syringe.
- Attach the 23-gauge needle to the syringe for vaccine administration.
- After reconstitution, the vaccine should be injected promptly.
- Record the batch number from the box.



Pneumococcal Conjugate Vaccine (PCV) Prevenar

PCV is now available in packs of 1 and 10 for both the new schedule and catch-up campaign.

Hepatitis B vaccine - Fendrix

Fendrix is a new Hepatitis B vaccine which will be available from the National Cold Chain service from November 2008.

It is indicated for active immunisation against hepatitis B infection for **patients with renal insufficiency** from age 15 onwards.



Inactivated Polio Vaccine - IPV

Inactivated Polio Vaccine (IPV) has been withdrawn by the manufacturer from the end of August 2008 and will no longer be available from the National Cold Chain service.

The only alternative vaccine is dT/IPV – Revaxis for those aged 6 and over requires authorisation and can be sourced through the National Cold Chain Service.

diTe Booster for hospitals

New stocks of diTe booster have arrived and are available for all sites including hospitals.

Out-of-date vaccines

There have been instances where out of date vaccine has been administered to children. Please ensure that vaccines are checked prior to administration.

Vaccines that have passed their expiry date should not be used

- Vaccines are not licensed beyond their expiry date
- If an expired vaccine is administered this is not counted as a valid vaccination
- Revaccination (if age appropriate) with an appropriate in-date licensed product is recommended.



Vaccine returns service

Only 25% sites have used the returns service so far in 2008

Whether you are a GP, HSE or hospital site please use the vaccine returns service – it's **FREE** and allows us to provide you with a better service.

The returns service is for

- unused expired vaccines in their original packaging
- vaccines that have had a break in cold chain storage
- vaccines with a product defect

Please complete the Vaccine Return Form prior to returning vaccines. The driver will ask you to place any such vaccines into a box which is to be sealed with the returns form. If you need more of these forms please contact Customer Services.

DON'T INCLUDE SHARPS, OTHER DRUGS OR CLINICAL WASTE
