# **Children First**

Children First refers to <u>Children First: National</u> <u>Guidance for the Protection and Welfare of</u> <u>Children 2017</u> and the <u>Children First Act 2015</u>. It is a generic term used to encompass the guidance, the legislation and the implementation of both. Children First promotes the protection and welfare of children and outlines how to help protect them from harm or abuse.

### What we do...

Our <u>Office</u> aims to support the HSE, and its funded services, to safeguard children through the effective implementation of Children First.

We have a key functional role, at national and at a local level, in supporting implementation, compliance and developing and delivering training and other resources in relation to Children First.

### How we do it...

We focus on four key areas of work:

**1.** Supporting Community Healthcare Organisations and Hospital Groups to understand requirements and plan for effective implementation of Children First.

**2.** Conducting <u>Children First Compliance</u> <u>Assurance Checks</u> to provide a level of independent assurance to services and HSE senior management.


**3.** Delivering <u>Training</u>, and briefings, directly to staff.

**4.** Developing new resources and policy documents in line with our <u>Training and</u> <u>Resource Strategy</u>.

## Mandatory Children First Training

**'An Introduction to Children First'** is a mandatory eLearning programme for all staff of HSE and HSE Funded Services, and must be completed on <u>HSeLanD</u> every 3 years. It only takes 90 minutes and certificates should be submitted to line managers.

## **Supplementary Training**

We currently offer the following supplementary training sessions:

- Children First Workshops for Mandated Persons
- Recognising and Responding to Child Abuse and Neglect Workshops
- Workshops for undertaking Risk Assessments & developing Child Safeguarding Statements
- Children First Briefings for Line Managers

# A bit more about... Children First Compliance in the HSE

Children First Governance Structures are in place to support the implementation of Children First throughout the HSE. The Children First National Office is supported by a Children First Oversight Committee and Operational Steering Committees (OSCs) have been established at National, Community Healthcare Organisation and Hospital Group levels.

#### **Children First Bi-Annual Progress Reports**

Children First Operational Steering Committees are required to submit two implementation progress reports per year to the HSE Children First National Office. This information is collated into a National Summary Report, which is presented to the HSE Senior Leadership Team.

#### Implementation and Compliance Self-Audit Checklist for HSE & HSE Funded Services

All HSE services complete this <u>checklist</u> annually to gain a self-assessed measure of Children First Compliance. Services should be able to produce copies of completed checklists on request.

#### Children First National Office Compliance Assurance Checks

The Children First National Office has recently started undertaking Children First Compliance Checks. The objective is to gain an independent measure of Children First Compliance at service level with a view to improving Children First Implementation and practice.

#### **Internal Audit**

Children First has formed part of the agreed Internal Audit Schedule since 2021. <u>Internal Audit</u> look for evidence of Children First implementation and compliance, for example, a service's Self-Audit Checklist, Child Safeguarding Statement and risk assessments, training certificates, procedures and evidence that staff understand their roles and responsibilities.

The HSE Children First Awareness Campaign took place from the 25 September to 1 October 2023. This year's campaign focused on the responsibility of organisations under Children First. Many events and briefings took place nationally across various HSE sites.

# Key messages

All organisations working with children and young people (<u>Relevant Services</u>) are required to **develop policies and procedures** to create a safe environment for children availing of a service.

Relevant Services are required to keep children safe from harm and to undertake <u>Child Safeguarding Risk</u> <u>Assessments</u> and develop and display <u>Child Safeguarding Statements</u>.

Staff who are **Mandated Persons** as defined in Schedule 2 of the act must know about their legal obligations under Children First.
