# Developing Child Safeguarding Statements in the HSE

All organisations providing 'relevant services', to children and families must develop a Child Safeguarding Statement (CSS) under the <u>Children First Act 2015</u>. This is a written Statement that specifies how the service safeguards children from harm. Child Safeguarding Statements must be informed by Child Safeguarding Risk Assessments.

HSE Guidance for Developing and Reviewing Child Safeguarding Statements is available. The guidance includes a HSE Child Safeguarding Statement template and other useful resources.

### How the guidance works...

The guidance is divided into two parts. Part A provides a short step by step guide to the process.

Part B provides a template for undertaking your Child Safeguarding Risk Assessment. The template is prepopulated to help you as you fill it in. You will need to edit it along the way to make it specific to your service.

The template Child Safeguarding Statement is available in both English and Irish. All of these resources are available from the HSE Children First Website.



Display your Statement in a prominent place wherever your service is provided.

It is recommended that HSE Child Safeguarding Statement templates are printed in A3 and displayed alongside one or both of our child friendly CSS posters which you will find at <a href="https://www.hse.ie/childrenfirst">www.hse.ie/childrenfirst</a>.



Practice tip: posters for younger children should be hung down low at their eye level.





## Responding to Retrospective Disclosures of Childhood Abuse

The Court of Appeal determined in December 2023 that mandatory reporting requirements only apply where there is a concern for a child who is under 18 years of age.

To reflect the decision of the courts the <u>HSE Child Protection and Welfare Policy</u> was updated to clarify how staff should respond when an adult discloses childhood abuse. If you would like further detail on this <u>judgement</u> please visit <u>www.hse.ie/childrenfirst</u>.

#### So... what does this mean for me?

This means that if an adult discloses to you that they were abused as a child you must consider whether a child or children (currently under the age of 18 at the time of the disclosure) could be at risk of abuse or neglect. If you have **concerns** you must send a report to Tusla; if you are a Mandated Person this is a legal requirement. Mandated Persons are listed in schedule two of the Children First Act 2015. If you don't have concerns for a child under 18 years of age then you are not required to make a report to Tusla.

Be sensitive and supportive to the person disclosing abuse.



Speak to your line manager and if you need further advice you can contact a Tusla duty Social Worker.



Consider whether the information needs to be reported to the Gardaí.



**Remember!** You do not need the identifying details of the child or the person subject of abuse allegations to make a report.

Think: Do you have current concerns for a child or children or concerns for a child in the future?

Continue to support and work with the person who disclosed to encourage their engagement with Tusla (if appropriate).
