### What are the Stages of Clinical Audit?

1. Selecting a Clinical Audit Topic

A topic is an area of practice that needs to be checked. It can be about what was needed, what was done or what was expected to happen to ensure high quality care.

#### 2. Identifying Standards

Involves finding the latest evidence of best practice or looking for experts recommendations about the topic.

#### 3. Collecting Data

Means reviewing medical records, observing healthcare professionals do their work or asking patients and families about their care experience.

#### 4. Measuring Performance

Comparing the care given to patients to latest standards using simple mathematical analysis.

#### 5. Implementing Change

Making improvements if result falls below the standards.

#### 6. Repeating the Audit

Wait for change to happen, then repeat the audit to monitor progress and confirm improvements.

### What is a Clinical Audit?



A **Clinical audit** is one of the ways healthcare professionals check that the care they provide to patients is safe and effective based on the latest standards of care.

Doctors, nurses and other healthcare professionals do clinical audit as part of their responsibilities to check that the care they provide is on par with latest standards.

A clinical audit involves selecting an area of practice that needs to be checked. It does not involve checking up on the individual healthcare worker performance or reviewing the care given to a particular patient.

If the audit results show areas that could be improved then changes are made and the audit is repeated to monitor progress and confirm improvement.

# Privacy and Confidentiality



We may use information contained in your healthcare record in order to carry out a clinical audit.

You will not be contacted directly and you do not need to give your consent if we use your healthcare information for a clinical audit.

This is because your name and personal details will not be included in the audit findings and audit report.

Sometimes a clinical audit involves patients taking an active part in the audit process and your personal details are an important part of the audit. In this type of audit you will be asked to give your consent.

## Types of Clinical Audit



There are different ways to do a clinical audit:

- Reviewing patients healthcare records.
- Observing healthcare professionals do their work.
- Asking patients and families about their care experience.
