It assists in an early warning mechanism for issues that require local action and/ or escalationIt is important to note tertiary and referral maternity centres will care for a higher complexity of patients (mothers and babies), therefore clinical activity in these centres will be higher and therefore no comparisons should be drawn with units that do not look after complex cases.Maternity Safety Statements form part of the suite of key performance indicators for the maternity services. Hospitals must populate and publish on a monthly basis (2 months in arrears). Additionally the statements are discussed at the Hospital Group Maternity Network meetings with the National Women and Infants Health Programme as part of the guality and safety agenda.
