This is the Q3 2023 implementation monitoring report for *Connecting for Life* (*CfL*). It will provide an overview of the work carried out by strategy lead agencies from July 2023 to September 2023.

To date in this period, of the 67 actions in CfL, **updates were received on 59.**Of these 59 actions for which updates were received, **3 were logged as needing attention and 2 were logged as off track** The majority of actions were considered to be on track. Further detail on the 'needs attention' and 'off track' actions are provided at the end of this report.

The NGO quarterly CfL implementation report (Q2 2023) has been completed and will be available here shortly.

Some highlights from this period include:

- Events and campaigns took place around the country for World Suicide Prevention Day 2023 (HSE NOSP)

- Five pilot sites currently being recruited to support adaptation of Minding your
 Wellbeing programme for delivery with older people. (HSE H&W)
- Launch of New "On Feirm Ground 2", which equips trusted professionals to spot the signs of a farmer who may be struggling and how to signpost them to appropriate supports. (DAFM)
- STORM training agreement with trainee GP scheme West. Participants recruited across a range of Mental Health professions to attend training in CAMS. (HSE NOSP)
- Five prevention initiatives targeting drug and alcohol use in specific populations funded by Dept of Health following a tendering process. (HSE PC).
- The national CAMHS Hub Model of Care was launched by Minister Butler on 7 September 2023.
- NEPS have developed guidance and resources for school staff who are supporting children and young people who are self-harming or at risk of self-harm See gov.ie (DoE)
- All 6 SCAN nursing posts have now been recruited with the final person to commence in Q4. (HSE MH Ops)
- NOSP staff delivered two oral presentations and two poster presentations at the IASP conference 2023.
- Dissemination plan drafted for paracetamol educational materials, including plans for a launch event on October 17th at the Department of Health for key stakeholders. (DoH)
- NOSP has established a National Advisory Group to develop a Deaths in Public Places Toolkit, with CCMA RCCH Committee representation. (LGMA)
- Tender for overall evaluation of CfL has been advertised. Procurement Review Group has been established. (HSE NOSP)

Goal 1: Improved understanding

1.1 Understanding suicidal behaviour

- Healthy Ireland data received by NOSP/NSRF, data analysis plan being prepared. (HSE NOSP)
- HSE Mental Health Promotion Plan: Ongoing meetings with lead partners to support implementation on a range of action areas across 27 actions. (HSE H&W)
- National Mental Health Promotion Plan: Final report and executive summary are now complete. Work has commenced to translate the work done to date into a publishable document which will outline the high-level actions that will deliver mental health promotion, through a whole government approach and cross-departmental consultation and collaboration will form part of this work. (DoH)
- Media strategy for YourMentalHealth campaign agreed for Q3 and Q4.
 Creative refresh began for social media. Paid Search key words under review. Work to update online content on supports and services continued. (HSE MH Ops)
- Successful IOAD event on the 31st of August 2023. 72 attended in person. 168 attend online. Two additional initiatives launched in Q3: a) Provision of Naloxone to prisoners with a history of opioid use on release from prison and information posters placed outside each prison in ireland with QR code directing to resources, b) Nalox-Home Pilot Collaboration with St. James' Hospital to provide intranasal naloxone to all vulnerable individuals on discharge from Emergency Department. Families Matter Webinar hosted by the NSIO in relation to naloxone education and training opportunities.(HSE PC)
- HSE NSIO Safer Nightlife Festival programme continued in Q3 with 75 volunteers present providing harm reduction information at Electric Picnic. In addition, back-of-house testing obtained 90 samples at EP and issued 4 risk communications to attendees. (HSE PC)

1.2 Awareness of services

- Currently working on My Mental Health Plan design, development, content, algorithm refinement and location on website. Content updates on ymh.ie continue with input on CAMHS, Nationally Counselling Services and services and supports. Digital Mental Health Plan overview presented to Digital Mental Health Specialist Group September 7th. (HSE MH Ops)
- As part of the YourMentalHealth campaign social media posts were developed to promote mental health to a range of priority groups including a series of posts for Men's Health Week. We also shared Exam Stress content for Young people and posts for Traveller Pride Week. We focussed on a series of key dates including World Suicide Prevention Day, and all posts are performing strongly. (HSE MH Ops)

1.3 Reducing stigma

 See Change Green Ribbon campaign launched and commenced in September 2023 ongoing for month. World Suicide Prevention Day 2023 - campaign partner pack distributed to stakeholders and internally in HSE. Joint HSE/DoH press release. Stakeholder engagement event also completed. BelongTo 'Better Out Than In' help seeking Campaign commenced September. Spunout Suicide Bereavement Campaign commenced September. (HSE NOSP)

1.4 Media and reporting

- Engagement during Q3 with relevant partners including Samaritans, Headline, Department of Health and NSRF on related streams of work and to consult on the establishment of Coimisiún na Meán. Current consideration to scope and TORs for combined Media and Online Safety Special Interest Group.
- Headline Mental Health Media Awards (MHMA) 2023 opened in September.
- Headline complaint not upheld by Press
 Ombudsman re application of Principle 10.

 Headline have submitted an appeal of this decision.
- Currently disseminating WHO revised media guidelines (September 2023).
- Work underway with new 'Real-time Social Media' group (with ROSPs) to develop good practice postvention media and social media assets. (HSE NOSP)
- CNAM received over 50 submissions in response to call for inputs on developing first online safety code. (Coimisiún na Meán)
- Since the last reporting, there have been no complaints with respect to Principle 3 of the Code of Programme Standards. CNAM continues to engage with stakeholders on the issue of coverage of suicide and self-harm, including most recently engagement with Shine and also attendance at the HSE NOSP seminar organised to recognise National Suicide Prevention Day. (Coimisiún na Meán)

 working in line with the HSE National Policy on Access to Services for Children and Young
 People with Disability and Developmental Delay, including ongoing promotion of Individual
 Family Service Plans through Children's Disability Network Teams (CDNT); services for
 children with complex needs, including those impacted by Adverse Childhood Experiences.
 (HSE MH Ops)
- Recruitment ongoing for mental health service associated with St James' Hospital and
 Housing First posts. Community Services Enhancement Fund Traveller-specific projects are
 developing and providing interventions. CSEF funding also supporting projects in Sligo, with
 an additional Family Support Worker and a Young Men's Programme. Resource allocated via
 NSIO to support those refugees and IP applicants with complex needs to ensure
 accommodation is maintained. (HSE PC)
- Launch of New "On Feirm Ground 2" Programme at the National Ploughing
 Championships. The programme equips trusted professionals to spot the signs of a farmer
 who may be struggling and how to signpost them to appropriate supports. It will be expanded
 to other professionals who work with farmers including private Vets and DAFM staff. (DAFM)
- National Trainer in post. STORM training agreement with trainee GP scheme West.
 Participants recruited across a range of Mental Health professions to attend training in
 CAMS. Aligning also with Rec 100 of StV, HSE and ICGP met to develop enhanced training
 opportunities for trainee GPs in mental health and provide detail on HSE mental health
 Services (including digital mental health services). This will enhance GPs awareness and
 access to relevant HSE mental health services. (HSE NOSP)
- IPAS staff are undergoing safeTALK training in 3 sessions. (DCEDIY)

- From the 1st July to 21st September, 222 learners completed the SAOR eLearning – 998 in total up to 21st September this year. From the1st July to 21st September. 132 learners completed the Hidden Harm eLearning - 437 in total up to 21st September this year. Development of SAOR Extended Brief Intervention Model to be piloted in CHO9 in partnership with the HSE Alcohol Programme. Recruitment underway for 9 SAOR practitioners, one in each CHO area to support the Health Diversion programme when operational. In partnership with TUSLA, continued progress on National Hidden Harm Programme. (HSE PC)
- Advisory structure review complete. New HEA Advisory Group on Student and Staff Health and Wellbeing to be established in Q4. Group will advise HEA on implementation of National Student Mental Health and Suicide Prevention Framework, as well as the Higher Education Healthy Campus Charter and Framework. A Community of Practice/Practitioner Network focusing on mental health and suicide prevention will also be established. (HEA)
- Five prevention initiatives targeting drug and alcohol use in specific populations funded by Dept of Health following a tendering process. The five streams within the programme are: school based, general youth, family based, environmental prevention and higher education settings. This was launched in June 2023 and projects are developing through Q3 and Q4. (HSE PC).
- Implementation of the 'Enhanced Transition Plan' will be the responsibility of the new HSE Youth Mental Health office with monitoring provided by the CYP workstream. Workstream 2 (0-25 MHS): Two engagement and consultation events on the long-term proposed reconfiguration design have taken place. (HSE MH Ops)
- Guidance on Reluctant Attendance and School Avoidance Behaviour developed. NEPS has
 developed training for school staff Introducing a Trauma Informed Approach, the Stress Factor:
 Getting the Balance Right'. 1,468 school staff have registered for training. NEPS have developed
 guidance and resources for school staff who are supporting children and young people who are
 self-harming or at risk of self-harm See gov.ie. NEPS Psychologists are available to deliver a
 presentation to schools to build awareness, knowledge and understanding of self-harm. (DoE)
- As of 1st Oct, 3775 people enrolled on Critical Incident e-learning course and 1838 have fully completed. The introduction of two strands of a pilot programme of counselling and mental health supports in selected primary schools. Strand 1 will see the provision of one to one counselling support to small numbers of children in selected schools. Strand 2 sees the establishment of Education Wellbeing/Mental Health Teams and introduction of Wellbeing Practitioners to support schools in cluster areas under the direction and supervision of NEPS. 3.1.2 Develop and implement a range of agency and inter-agency operational protocols (including protocols for sharing information and protocols in respect of young people) to assist organisations to work collaboratively in relation to suicide prevention and the management of critical incidents. (HSE Acute Ops)

Acute Operations is currently engaging with NOSP and Mental Health Services to re-assess an operational plan to complete relevant CFL strategy actions across hospitals. There have been a number of challenges to the implementation of the actions at an operational level and there will be on-going issues to the management of programme. This mostly relate to the consistently high level of demand on unscheduled acute care services and the availability of ED staff for training. (HSE Acute Ops)

Action 3.1.4: Evaluate as appropriate targeted initiatives and/or services for priority groups.

IPSDS area level infographics & mortality rates bulletin published on website. Delay in applying small area codes data to facilitate analysis (by area of deprivation). (HSE NOSP)

Goal 7

7.1.1 Conduct proportionate evaluations of all major activities conducted under the aegis of Connecting for Life; disseminate findings and share lessons learned with programme practitioners and partners.

- Evaluation of Suicide Observatory has been deferred until data from IPSDS can be made available.
- NOSP (with DoH support) has developed the Request for Tender for the overall evaluation of CfL. There was a delay in publishing the
 document on the E-Tenders website. It has now been published. (HSE NOSP)





Goal 2

Implement consistent, multi-agency suicide prevention action plans to enhance communities' capacity to respond to suicidal behaviours, emerging suicide clusters and murder suicide. The plans will be the responsibility of HSE Mental Health Division and aligned with HSE Community Health Organisations structure, Local Economic and Community Plans and Children and Young People's Services Committee's (CYPSC) county plans.

There are still outstanding local CfL action plans. Action plans for CHO Cork and CHO Kerry to be reviewed by the Mental Health Management team at the end of September. The CHO 3 plan is at final stages of design and due to be approved by the Chief Officer. (HSE MH Ops)

Goal 3

3.1.2 Develop and implement a range of agency and inter-agency operational protocols (including protocols for sharing information and protocols in respect of young people) to assist organisations to work collaboratively in relation to suicide prevention and the management of critical incidents.

The deaths by suspected suicide data sharing protocol between the HSE and An Garda Síochána still has not been signed despite having been tabled by the Garda Executive in November 2022 and regular contact with the policy writers. (HSE NOSP)
