This is the Q4 2023 implementation monitoring report for *Connecting for Life (CfL)*. It will provide an overview of the work carried out by strategy lead agencies from October 2023 to December 2023.

To date in this period, of the 67 actions in CfL, **updates were received on 62.** Of these 62 actions for which updates were received, **5 were logged as needing attention and 4 were logged as off track** The majority of actions were considered to be on track. Further detail on the 'needs attention' and 'off track' actions are provided at the end of this report.

The NGO quarterly CfL implementation report (Q3 2023) will be completed and available here shortly.

Some highlights from this period include:

- A draft document of the high level actions for the national Mental Health Promotion plan has been produced. Cross-government engagement is ongoing to agree actions and appropriate wording. It is anticipated that the final draft will be completed by end of Q4. (DoH)
- Headline's appeal to a Press Ombudsman decision in relation to Principle 5.4 of the Code of Practice was successful (HSE NOSP)



- In early December, Coimisiún na Meán will publish its Draft Online Safety Code. This will propose
 rules to address online harms including suicide and self-harm. This is a public consultation process
 and civil society bodies, Public bodies and government departments will be invited to respond.
- Researcher commissioned and advisory group established to develop Deaths in Public Places toolkit. (HSE NOSP)
- STORM training was delivered to 11 trainee GPs in GP Scheme West Sligo. Training in Grief and Bereavement delivered to 204 Counselling in Primary Care staff members. CAMS training delivered Q4, CHO 7. (HSE NOSP)
- There were 2 sessions of safeTALK delivered to IPAS staff in October attended by 50 IPAS staff members (DCEDIY). 48 personnel trained in SafeTALK over Q4, to date (DoD). SafeTALK training delivered internally in DSP throughout 2023 has had a high uptake. To date in 2023, the session was delivered to 260 staff members. (DSP)

- All 4 Traveller Wellbeing through Creativity projects are underway and operating. Meeting with projects scheduled to discuss progress and evaluation. (HSE H&W)
- Research to establish evidence base and best practice examples of shared care between PC and specialist MH services complete. Included review of Irish and international literature and a number of case studies. (HSE MH Ops)
- DRCD hosted an LCDC networking event in September 2023 that featured a presentation on Connecting for Life. DAFM, with the support of DoH and the HSE, hosted the 'Cultivating Mental Well-being in Rural Ireland' conference in November.
- The HSE NOSP and NSRF presented a review of bereavement supports provided through the coronial system in other jurisdictions to the Dept Justice.
- National Centre for Clinical Audit approved advancement of a feasibility study to establish National Probable Suicide Registry. Meeting in Q4 to review incident specific review tool for community mental suspected suicides. (HSE MH Ops)
- On-going production of report from the Self-Harm Assessment and Data Analysis (SADA) project with support from NOSP. Appointment of joint funded SADA Project Officer to assist in more detailed interrogation of available data. This will assist with data quality and translate to more effective policy and protocol development. (DoJ/IPS)



Action 3.1.1 Integrate suicide prevention into the development of relevant national policies, plans and programmes for people who are at an increased risk of suicide or self-harm.

48 Personnel trained across the DF in Q4, to date. Impacted by availability of personnel to undergo the training. Proposing the integration of SafeTALK training into Recruit training and Potential NCO training.(DoD)

Action 3.1.4 Evaluate as appropriate targeted initiatives and or services for priority groups.

Delay in data analysis. (HSE NOSP).

Goal 4

Action 4.1.3: Ensure that those in the criminal justice system have continued access to appropriate information and treatment in prisons and while under Probation Services in the community. The Irish Prison Service and the HSE National Forensic Mental Health Service will complete an agreed memorandum of understanding on improved links through the NFMHS Prison In-reach Service and the Probation Service will engage with the HSE on maintaining and developing access to community psychiatric services.

This has been delayed but there is a meeting scheduled to progress clarification and discussion on agreement of the MOU. (DoJ/IPS)





Goal 5

Action 5.3.1 Through the Death in Custody/Suicide Prevention Group in each prison, identify lessons learned, oversee the implementation of the corrective action plan, and carry out periodic audits.

There has been a delay in accessing the data. The SADA report for 2020 & 2021 is in final editing stage with NSRF & IPS. High level results are being presented to the National Suicide & Self-Harm Prevention oversight group on the 13 Dec 2023. (IPS/DoJ)

Action 5.3.3 Implement the IPS Prisoner Release Policy, to ensure care, treatment and information is provided, including identifying the appropriate mental health services in each area for those leaving prison. This will include appropriate links with the community mental health services.

Updating IPS seclusion policy with new NICE guidance progress development has been hindered with resource and capacity issues. (IPS/DoJ)

The deaths by suspected suicide data sharing protocol between the HSE and An Garda Siochana has been approved by the Garda Data Protection Office, with minor edits. It has not yet been signed. (HSE NOSP)

Action 7.2.3 Collect, analyse and disseminate high quality data on suicide and self-harm and ensure adequate access to, and understanding of the data among those working in suicide prevention across all sectors.
