#### **A statement about the effectiveness of the approved centre's actions to reduce or, where possible, eliminate the use of seclusion**

The staff working in the AAMHU are committed to providing the highest possible quality service in keeping with the HSE values of care, compassion, trust and learning. They adopt a biopsychosocial approach which emphasises a recovery framework and are committed to providing a recovery orientated service; using expertise, knowledge and skills, together with the service user, their family member and/or representative. The AAMHU implements the Safewards Model as an evidence based approach to reduce conflict and containment in the approved centre. Ten targeted interventions are implemented which enhance communication and the therapeutic relationship resulting in a positive effect in reducing the use of seclusion. Staff in the AAMHU also conduct a Safety Pause each day which aims to identify what safety issues staff need to be aware of and facilitates early intervention and proactive strategies to be implemented to reduce the need for seclusion. It is a culmination of the above that assist the AAMHU in reducing and where possible, eliminating the use of restrictive practices. Throughout the course of 2024, the AAMHU continued to promote a reduction in in the use of seclusion. The ethos and ambition of the staff working in the Adult Acute Mental Health Unit remains the same for 2025, where service user's human rights and person centred care are upheld to the highest standards.

The AAMHU implements and complies with a policy developed by the Galway Roscommon Mental Health Services titled 'Restrictive practices reduction strategy and policy'. This policy is underpinned by the recommendations from Sharing the Vision (2020) and the Galway Roscommon Mental Health Nursing Services Strategy (2022-2027) which collectively support and promotes human rights and trauma informed care. The policy outlines that all restrictive practices should only be used as a last resort in rare and exceptional circumstances. A Multidisciplinary review and oversight committee reviews all episodes of seclusion quarterly. This process promotes learning for all concerned and provides an opportunity for reflection. This learning informs practice and helps to identify antecedents which will assist in preventing further episodes of seclusion into the future. The service user is encouraged to participate in this process. This committee also seeks ways to improve practices and further reduce episodes of seclusion through Safewards promotion and quality initiatives. Safewards is the model of care promoted by the AAMHU as a prime driver in the reduction of restrictive practices. A local implementation group oversees the implementation and monitors its effectiveness through regular meetings.


