### Background

It is well documented that the proportion of cancer incidence attributable to modifiable lifestyle and environmental factors is estimated to be between 30% and 50%<sup>1</sup>. Cancer prevention is highlighted as a corner stone of The National Cancer Strategy 2017-2026<sup>2</sup> as it offers the most cost-effective long-term approach for cancer control. Partners working to strengthen cancer prevention initiatives is recognised in the National Cancer Strategy as a key element in advancing the cancer prevention agenda.

Tackling modifiable risk factors has vast potential to reduce the risk of cancer, and other non-communicable diseases, for the people of Ireland. Addressing modifiable risk factors requires a multi-agency, multi-disciplinary approach which must address action areas outlined in Ottawa Charter for Health Promotion:<sup>3</sup>

### Establishment of the ICPN

The Irish Cancer Prevention Network (ICPN), the first of its kind in Ireland. It is a collaboration between the HSE National Cancer Control Programme, the Irish Cancer Society (ICS), the Marie Keating Foundation (MKF), Breakthrough Cancer Research (BK) and the HSE National Screening Service (NSS). National organisations that have a focus on cancer prevention in Ireland.

The network was established in 2018, following a review of international networks, lectures from the founders of the Scottish Cancer Prevention Network and a workshop with organisations on establishing an Irish Cancer Prevention Network.

The first ICPN memorandum of understanding (MoU) was signed by the founding organisations (ICS, MKF, BK and NCCP) in December 2018. The HSE National Screening Service (NSS) joined the Irish Cancer Prevention Network in 2020.

The network established itself over the years and an updated MoU was signed in 2024.

### **ICPN** Objectives

The ICPN MoU outlines the objectives and expected outcomes of the Network. The overarching objective is to contribute to the development of a culture and environment conducive to cancer prevention for the Irish population and support the delivery of the National Cancer Strategy 2017-2026 recommendations in relation to cancer prevention.

The ICPN brings stakeholders together, who are specifically working in cancer prevention, to:

- collaborate on cancer prevention initiatives in Ireland;
- agree consistent evidence-based cancer prevention public awareness messages;
- disseminate up to date cancer prevention research;
- support members and organisations in cancer prevention queries;
- facilitate peer learning;
- support the implementation of the National Cancer Strategy 2017-2026;
- support national programmes with a unified voice.

Bringing together national organisations strengthens supportive work in cancer prevention with a unified voice.











### ICPN Co-ordination and collaboration

The objectives and expected outcomes are accomplished by the joint responsibility of the network members undertaking the following activities:

- Co-ordination of the network by the NCCP.
- Agreement of annual deliverables.
- Minimum quarterly meetings annually to share planned cancer prevention initiatives and research in cancer prevention. Meeting chair rotates between members.
- Group agreement on aligned consistent evidence-based cancer prevention messages/language, in line with international messages tailored for the Irish context.
- Annual collaboration cancer prevention initiatives including public engagement, education for health and social care professionals and advocacy related to cancer prevention.
- Establish the group as a contact point for cancer prevention consultation.
- Agreed advocacy for cancer prevention initiatives.

As of May 2025, there has been 31 network meetings progressing delivery of objectives and sharing initiatives.

### **ICPN** Achievements

#### Policy

Together the ICPN is a unified voice for policy change to reduce cancer risk for people living in Ireland.

An application to become an affiliate member of the European Cancer League was successful in 2019. As part of this the ICPN was part of the European Cancer League that called for all European Union (EU) and WHO/Europe member states to take immediate action towards fulfilling the ambitious goal of eliminating cervical cancer as a public health problem, signing a joint statement.

The ICPN was part of the Tobacco 21 Alliance calling for a rise in legal age for sale of tobacco. The Public Health (Tobacco) (Amendment) Act 2024 Act raised the minimum legal age of sale of tobacco products to 21 years. It was enacted in December 2024 and will take effect from February 2028.

Additionally, the ICPN supports implementation of the Public Health Alcohol Act, co-signing multiple letters to government calling for enactment of the legislation, in particular warning labels that












include the link between alcohol and cancer on products. The Public Health (Alcohol) Act 2018 was developed to address the high volumes and harmful patterns of consumption of alcohol prevalent in Ireland. Section 12 of the Act provides for health labelling on alcohol products and was due to be commenced in May 2023 however the government has taken the decision to delay the introduction to 2028. The law provides for health information and health warnings of the risks associated with alcohol consumption to be presented on the labels of alcohol products and includes a warning of the direct link between alcohol and fatal cancers.

#### Ezines

The ICPN circulates a quarterly ezine which includes articles on cancer prevention evidence, initiatives, resources available and related research/reports.

A total of 17 ezines have been sent since December 2020. From October 2023 the ICPN moved to a new platform to disseminate ezines. Figure 2 below details engagement with the ezine.

The number of subscribers has grown to greater than 1000 individuals, with only 25 individuals unsubscribing from the ezine during this time period.





#### Public education

Since 2019 the ICPN has delivered public educational and engagement events for World Cancer Day which is held on the  $4^{th}$  of February each year.

In 2019 and 2020 the ICPN collaborated with parkrun, undertaking press related activity to increase awareness and engagement with physical activity to reduce cancer risk. Figure 3 illustrates some of the promotional activity.

During the Covid pandemic the ICPN moved the annual World Cancer Day event online, hosting public webinars. Annually a press release is published, radio and printed press interviews are conducted complimented by a social media campaign and direct email to ICPN members networks. ### ICPN members community initiatives

ICPN members delivered a range of community and educational initiatives including

The Marie Keating Foundation: The Foundation's Schools Cancer Awareness Programme reached over 14,600 students during the 2023/2024 academic year, delivering vital education on cancer prevention and awareness. Their Nursing Outreach Service has supported more than 8,500 people annually across over 320 communities, providing essential health information and support, with a particular focus on underserved communities. Through their Corporate Wellness Programmes, the Foundation educates nearly 5,000 people annually in workplace settings, delivering both in-person and online sessions to a wide range of corporate audiences.











- Irish Cancer Society: The Your Health Matters Roadshow, which aims to reduce people's risk of cancer and improve early detection, attended 19 counties over 49 days in 2024. This nurse-led community outreach initiative is delivered in shopping centres in areas of most disadvantage. Close to 2000 people had a health consultation with a cancer nurse at the Roadshow and a further 27,000 people engaged with the information on screening, lifestyle advice and cancer symptoms.
- The HSE National Screening Service designed and piloted a Community Champions programme. In 2024, 5 pilot sites were identified. A total of 40 people across the sites have been trained as Community Champions by the Health Promotion team in the National Screening Service. These cover a range of workers from peer support workers, community health workers, migrant support workers, Roma support workers and health promotion staff. The types of interventions that are currently being delivered in communities include, group education, one to one education and support, use of small media, reducing out of pocket expenses, reducing administrative barriers and reducing structural barriers.
- The HSE National Cancer Control Programme established a network of regional Senior
  Health Promotion and Improvement Officers Cancer Prevention, who delivered extensive
  engagement and education sessions on cancer risk reduction with 200 groups of HSE staff,
  community organisations and the public in 2024, including a focus on marginalised
  populations.
- Breakthrough Cancer Research: Breakthrough Cancer Research marked a significant milestone in their collaboration with UCC, celebrating five years of pioneering advancements in cancer research. The partnership has catalysed cutting-edge research and advanced clinical applications to benefit people with some of the most challenging and low-survival cancers, including ovarian, liver, lung, stomach, brain, oesophageal, and pancreatic cancers. Breakthrough are currently supporting over 165 cancer researchers. Breakthrough Cancer Research nutritional cookbooks are available, covering cancer prevention and living with and beyond cancer.
- The HSE NCCP and Healthy Ireland won the award for the 'Best Public Information Campaign' for the SunSmart campaign. Judges highlighted the campaign "demonstrated well-identified objectives and audiences, strong research and hard-working execution".











#### Education

Annually, the ICPN hold an education event, online or in person, for health and social care professionals. The overarching aims of these events are to increase health and social care professional awareness about modifiable cancer risk factor research and initiatives, provide information about how they can support service user and signpost to relevant services and resources. Subject matter experts present on a range of topics. Figure 6 depicts the adverts for these events. Table 3 outlines these events and engagement. Evaluation of these events is conducted with most of the participants reporting an increase in their knowledge of cancer prevention and planning to use the information learned/resources in their work.

### Future for ICPN

The ICPN has successfully established a collaborative working environment across national organisations with an interest in cancer prevention. Each year the network has grown and initiatives such as the ICPN ezine, World Cancer Day webinars, health and social care professionals' education and consistent evidence-based cancer prevention messages to the public has strengthened. The network is the first of its kind in Ireland and provides a platform for shared learning and support for organisations work in cancer prevention.

"The National Screening Service is a proud member of the ICPN, which has had significant successes in promoting the importance of cancer prevention in all communities in Ireland.











Detecting and diagnosing cancer early is a critical step in reducing mortality from cancer. NCRI data has shown that our cancer screening programmes have contributed to improvements in survival rates, and in 'stage shift', where more people are diagnosed earlier and cancer is more treatable. These are welcome indicators of the impact of screening. There are also many more people who will never develop cancer because they choose screening. In cervical screening this means removing abnormal cells before cancer develops; in BowelScreen we remove polyps in the bowel before they can go on to become cancerous.

The network's emphasis on collaboration has enabled us to foster strong links. These links have enhanced the delivery of screening messages. Sharing resources and expertise to support prevention, particularly to educate health professionals and the public, have been highlights for our teams.

In 2024 the NSS hosted the first in-person ICPN event where members could learn from each other's work. The presentations included our Public Health and screening programme teams' work with Travellers to increase awareness of our screening programmes. Screening plays an essential role in cancer prevention and our work through the ICPN highlights this and our close collaboration with our ICPN partners. We in NSS look forward to playing our part in the network into the future.

The ICPN has a place to inform actions in relation to cancer prevention in the next National Cancer Strategy. It brings together national organisations, strengthening supportive work in cancer prevention with a unified voice".

The ICPN will continue to work towards annual objectives, maximising outputs and impact. It has the potential to grow providing membership to organisations with niche cancer prevention interests.
