

# Cork / Kerry Mental Health Promotion Project Grant 2022 Terms & Conditions

---

Following the publication of the [Stronger Together – HSE Mental Health Promotion Plan 2022-2027](#) the Department of Public Health South is providing funding in support of projects across Cork and Kerry that promote awareness about mental health.

The **Cork/Kerry Mental Health Awareness Project Grants** will be awarded by the HSE Department of Public Health in collaboration with HSE Cork Kerry Community Healthcare Mental Health Services, Suicide Prevention, Social Inclusion and Health Promotion & Improvement Department. The grants will support projects that address mental health promotion across Cork and Kerry with a focus on the following specific groups;

- Mental health promotion specific to infancy, childhood and young people (0-25 yrs.)
- Mental health promotion specific to the working age population and older people
- Mental health promotion specific to socially excluded groups
- Mental health promotion specific to the community - Belonging Well Theme

Applications for funding must be made on the **Cork / Kerry Mental Health Promotion Project Grant Application Form** and accompanied by the supporting documentation.

Applications will be considered by the Department of Public Health HSE South Cork & Kerry in collaboration with representatives from Cork Kerry Community Healthcare Mental Health Services, Psychology, Suicide Prevention, Social Inclusion and Health Promotion & Improvement Departments.

Once-off projects will be funded up to a maximum of €5,000 and the closing date for receipt of applications for the **Cork / Kerry Mental Health Awareness Project Grant** is 30th September 2022, for projects that will commence in 2022.

## Funding Allocation for 2022

The funding will be prioritised for projects that support a focus on mental health promotion in the Cork & Kerry region as outlined above. All applications must clearly state

- How the proposed project addresses a local need
- The demonstrable and measurable benefits of the project
- The project timelines – start and finish

## Eligibility Criteria

The funding is open to community and voluntary agencies that currently hold a Service Arrangement or Grant Aid agreement with the HSE.

- The grant is only available for projects which commence in 2022
- A project evaluation will be required for submission to the Director of Public Health on completion of the proposal
- Only one grant per organisation will be awarded.

## Outside of Scope of this Grant

- Projects that are the responsibility of other Government Departments.
- Projects that duplicate services or activities in an area.
- Servicing of debt.
- Projects that cannot commence in 2022\*

## Application Process

Applications for funding must be made on the **Cork / Kerry Mental Health Promotion Project Grant Application Form** and be accompanied by all requested supporting documentation. Applications will be coordinated and assessed by the Department of Public Health HSE South Cork & Kerry in association with relevant project team partners.

## Level of Funding

The level of contribution awarded under the fund will depend on a range of factors; including the type of project, availability of other sources of funding, and the overall number of applications seeking funding under the scheme. It is envisaged that grants will be made available up to €5,000 each.

## Closing date

The closing date for receipt of applications for the **Cork / Kerry Mental Health Promotion Project Grant** is **30th September 2022** with funding to be allocated in October / November 2022.
