Background

- Population Health is an increasingly prominent concept, however, there is no universally agreed definition for it.
- Sláintecare¹ and the HSE Health Regions Implementation Plan² highlight the need to move towards a population health approach and population needs.
- This project sought to explore the alignment of the HSE National Clinical Programmes (NCPs) with a population health approach given the central role of the NCPs in clinical design and service improvement.

A Collaborative Project



Objectives


- Develop a definition for population health and identify key principles of a population health approach.






Objective 3: An 'As-Is' Exploration of Population Health Alignment
