National incidence rate of 524.1/100K. Counties with the highest 14-day incidence rate are Monaghan at 1472.6/100K, Cavan at 1146/100K and Donegal at 1126.3/100K. A total of 5,080 deaths have been reported up to 08.30am 23/08/21.  As of 22/08/21 there were 318 admitted patients with COVID-19, of which 60 are

8. TESTING & TRACING			
	Testing There was a slight increase in testing yesterday (15,500) compared to last Monday (14,700). The numbers attending for testing at the weekends remains stable. CHO 1, 5 and 8 have seen an increase in attendances for testing. CHO 3 has reduced attendances. The testing demand remains within the capacity of the system, currently approx. 130,000 tests/week.  With the re-opening of schools and third level institutions, there is an expectation of an increase in the demand for testing and contact tracing. Both Testing and Tracing services are preparing for an increase in demand.  Antigen Testing Programme continues in the early years and third level institutions. A number of other institutions are going to join the programme. Pop-up testing facilities are still in use		Niamh O'Beirne
