### Speaker biographies



<u>Prof. Michael Barry</u> is a Consultant Clinical Pharmacologist and Head of the Department of Pharmacology & Therapeutics at the University of Dublin, Trinity College. He is the clinical director of the National Centre for Pharmacoeconomics (NCPE) which conducts pharmacoeconomic evaluations on medicines prior to reimbursement under the Community Drugs schemes in Ireland. Prof. Barry chairs the New Drugs Committee and the Medication Safety

Committee at St. James's Hospital, Dublin. In 2013 he was appointed as Clinical Lead for the HSE Medicines Management Programme. He is a fellow of the Royal College of Physicians in Ireland and is a specialty trainer for Pharmacology & Therapeutics. His research areas include the cost-effectiveness of high cost drugs including chemotherapeutic agents and biologic drugs, pricing and reimbursement and performance based risk sharing schemes. He has published widely on the cost-effectiveness of medicines in the Irish healthcare setting.



#### Dr. Helen Flint

Having trained in both general and psychiatric nursing, Helen holds post-graduate diplomas in coronary care and general intensive care. She was a Ward Sister at the Royal Free Hospital in London and Senior Nurse Manager and Hospital Manager in England before moving to Ireland in 1990 to take up post as Matron, Leopardstown Park Hospital and subsequently Director of Nursing, St. Colmcille's Hospital, Loughlinstown. Helen has both an MSc and

PhD from Trinity College Dublin. Her MSc is in Community Health and her doctorate from the Department of Pharmacology and Therapeutics is in safe and cost-effective prescribing. Helen is a Fellow of the Royal Academy of Medicine in Ireland and recipient of the Jacqueline Horgan Bronze medal



<u>Dr. Roisin Adams</u> is Deputy Head of the National Centre for Pharmacoeconomics. She was awarded a PhD for her work on the cost effectiveness of biologic agents in inflammatory rheumatological disease. She is a graduate of the Robert Gordon University, Aberdeen and trained in Ninewells Hospital, Dundee. In 2003 she was appointed Chief II pharmacist in St. James's Hospital where she specialised in palliative care and rheumatology. Roisin

completed her MSc. in Clinical Pharmacy at Queens University, Belfast. She leads the review group for pharmaceutical technologies at the NCPE. Her areas of interests include methods for preference elicitation and methodology of indirect comparisons for evidence synthesis.



#### Prof. Laserina O Connor

Laserina O Connor was appointed a clinical professor and joint clinical chair at University College Dublin (UCD) in partnership with the Mater Misericordiae University Hospital and St Vincent's Healthcare Group on 1st July 2013. She is the President of the Irish Pain Society and is lead coordinator of the MSc Advanced Pain Management/Prescriptive Authority and CPD and Diploma in

Diabetes Care. Laserina has an unconditional passion and commitment to make a difference to the world of the patient with pain and their daily narrative.



**Katie Murphy** is the Research and Development Officer with Cystic Fibrosis Ireland (CFI). Katie also acts as a patient advocate with a particular interest in promoting patient involvement in research, health technology assessment, policy development and the development of clinical care standards and practices.

<u>Olive O'Connor</u> is a patient, a mother and a carer who has first-hand experience of the complexities of modern medicine regimens and is the creative founder of Medistori health organiser.



<u>Prof. Peter Weedle</u> is a community pharmacist based in Mallow, Co. Cork with a particular interest in providing pharmaceutical care to elderly patients in nursing homes. He was involved in setting up the School of Pharmacy at UCC and has been in the College of Medicine and Health since 1995 on a part-time hasis

He has published many papers on medicine use and the elderly, his main interest over the past three decades. He is co-author of two books, Pharmacy and Medicines Law in Ireland and Medicines: A guide for everybody. This year through his company Infomed Mobile he has launched Apps for smartphones/tablets that cover indications, contra-indications, side-effects, dosage, drug-drug interactions, drugs in pregnancy, breast feeding, driving, sports and photosensitivity for all medicines in Ireland. He is currently working on integrating his medicine use review program (MOSS) with a GP practice computer system provider.



<u>Dr Brendan O' Shea</u> is a General Practitioner, practicing in Co Kildare, and is Lecturer at The Department of Public Health and Primary Care in Trinity College. He is also Medical Director at K Doc, a GP Out of Hours Co Operative in Kildare and West Wicklow. Research interests include chronic disease management, childhood overweight and end of life planning.

Dr Gearoid O'Connor and Dr Diarmuid O'Keefe are presently 4th Year GP Registrars at the TCD HSE GP Training Scheme, located in the Trinity Teaching Centre, Tallaght Hospital.

Dr. MaryJo MacAvin has been a part-time medical advisor in the National Medicines Information Centre (NMIC) in St James's Hospital Dublin since November 2005. She has been part-time course co-ordinator of a postgraduate course (pharmaceutical medicine) in Trinity College Dublin since 2004. In her role as medical advisor in the NMIC, she is the co-author of the NMIC publications *Therapeutics Today* and *NMIC Bulletin*, which provide updates on therapeutic topics to primary care physicians and other healthcare professionals. She is also involved with her NMIC colleagues in the education of medical BST trainees in the Royal College of Physicians of Ireland. She has the UK Postgraduate Training for General Practice Certificate of Experience for the United Kingdom (1992) and is on the Irish Medical Speciality Register for General Practice. She holds an MSc in Medical Education and a postgraduate diploma in statistics.



<u>Dr Tamasine Grimes</u> is Associate Professor, School of Pharmacy and Pharmaceutical Science, Trinity College Dublin and Research Pharmacist, Tallaght Hospital Dublin. Her current work combines research, teaching & learning, and clinical practice.
