It is understood that these will be provided soon.</p> <p>Neither sluice room has a large sink suitable for sluicing soiled linen and clothing; it is recommended that at least one be provided. One of the toilets beside the sluice rooms might be converted to accommodate this.</p> <p>Consideration should be given to provision of a staff-room, with appropriate ventilation and natural light.</p>	Recommendations
