Summary Findings of Current Nursing Home Inspection

- Under Care & Staffing the nursing home was compliant with 19 out of 21 regulations.**
On the basis of this inspection and under current nursing home regulations, there are issues that need to be addressed as outlined below in relation to the Care and Staffing.
- Under Management the nursing home was compliant with 27 out of 27 regulations.**
On the basis of this inspection and under current nursing home regulations, the inspection team would consider the nursing home to have a good standard of management.
- Under Physical Environment the nursing home was compliant with 8 out of 11 regulations.**
On the basis of this inspection and under current nursing home regulations, there are issues that need to be addressed as outlined below in relation to the Physical Environment.

Non-Compliance The over bed light in room 31 did not work.

Required Action Provide suitable and adequate lighting.

Non-Compliance A key was left on the inside of the door in room 15 allowing for a confused person to make an unsupervised exit from the premises.

Required Action Secure all external openings against unsupervised exits from the premises.

Timescale Immediate

Regulation number Article 14(b)

Non-Compliance Dispensers for alcohol hand wipes were dirty particularly the dispenser adjacent to the office

Required Action Such equipment must be stored and maintained in a clean and hygienic condition.

Timescale Immediate

Regulation number Article 19.1(g)

Non-Compliance On reviewing a selection of resident's files, it was evident that not all areas were completed.

Required Action This should be rectified immediately.

Timescale Immediate
