## **Integrated Inspection Report**

**Re: Inspection of Roseville Nursing Home under the Health (Nursing Homes) Act, 1990 and the Nursing Homes (Care and Welfare) Regulations, 1993.**

The Nursing Homes Inspection Team taken from an EHO/  
Medical/Nursing perspective inspected The **Roseville Nursing Home** on  
8<sup>th</sup> June 2007.

The inspection commenced at 10.00am and was completed at 2.00pm.  
There were 27 residents on this date. The Nursing Home is currently  
registered for 30 residents.

**Issues identified in previous Inspection Report date 30<sup>th</sup> November  
2006 have been satisfactorily addressed.**

### **Current Inspection**

The following issues require your attention and action.

**DESIGN:**

*Regulation 12 states:*

*The registered proprietor and the person in charge of the nursing home shall:*

- (b) *ensure that handrails are provided in circulation areas and that grab-rails are provided in bath, shower and toilet areas.*

**Non-compliance:** No handrails provided in the circulation areas in the extension area and also on the corridor leading to the back of the Nursing Home.

**Required Action:** Handrails to be provided

**Timescale:** Within one month

**STAFFING:**

*Regulation 10.5 states:*

*The registered proprietor and the person in charge of the nursing home shall ensure that:*

- (d) a sufficient number of competent staff are on duty at all times having regard to the number of persons maintained therein and the nature and extent of their dependency.*

**Non-compliance:** Insufficient care staff on night duty

**Required Action:** A second care assistant to be on duty from 8.00pm to 10.00pm and from 7.00am to 8.00am.

**Timescale:** One week

**ACCOMMODATION AND FACILITIES:**

*Regulation 11.2 states:*

*In every nursing home there shall be provided suitable and sufficient accommodation which meets the minimum standards as follows: -*

- (a) adequate accommodation and space in single and shared sleeping rooms and portable screens or screening curtains to ensure privacy for individual persons.*

**Non-compliance:** No screen provided for bed in Room 7.

**Required Action:** Screen to be provided

**Timescale:** Within one month

**MEDICAL PREPARATIONS:**

*Regulation 29 states:*

*The registered proprietor and the person in charge of the nursing home shall:*

- (a) make adequate arrangements for the recording, safe-keeping, administering and disposal of drugs and medicines.*

**Non-compliance:** No M.D.A. register in the nursing home

**Required Action:** M.D.A. register to be put in place.

**Timescale:** Immediate

**Recommendations:** That the nursing staff make themselves aware of An Bord Altranais medication management guidelines.

The Chairperson of the Nursing Home Inspection Team is to be notified in writing on or before the above dates indicating the steps taken by the Nursing Home to carry out the actions as required under the Regulations.
