Post Explanations	
<b>New</b>	<i>A post which has not previously been approved and is a new role or an additional post for an established department.</i>
<b>Replacement</b>	<i>An approved post which has become or is due to become vacant and approval is being sought to re-fill.</i>
<b>Restructure</b>	<i>An approved post where changes are being proposed to the terms and conditions – e.g working hours, contract type, location of post etc.</i>
<b>Change of Contract</b>	<i>an application submitted by the site on behalf of the consultant where they wish to change their contract from one contract type to another (excluding Type C as these applications are considered separately by the Type C Committee)</i>
<b>Replacement/Restructure</b>	<i>An approved post which has become or is due to become vacant and approval is being sought to re-fill &amp; where changes are being proposed to the terms and conditions – e.g working hours, contract type, location of post etc.</i>

<b>Recommended for Approval</b>	<i>when an application has been considered and discussed by CAAC and is recommended for approval</i>
<b>Recommended for Approval (subject to)</b>	<i>when an application has been considered and discussed by CAAC and is recommended for approval subject to a request for additional information which must be forwarded to the NDTP prior to any letter of approval being issued.</i>
<b>Deferred</b>	<i>when an application has been discussed by CAAC and a decision has been made to defer consideration, the CHO/HG will withdraw the application until such a time that it is appropriate to re-initiate with additional information.</i>
<b>Withdrawn</b>	<i>when an application has been discussed by CAAC and is subsequently withdrawn by the HG/CHO</i>
<b>Rejected</b>	<i>when an application has been considered and discussed by CAAC and is not recommended for approval</i>
