

1. Introduction

The Consultant Applications Advisory Committee (CAAC) was established by the CEO of the Health Service Executive (HSE) as per the Consultant Contract 2008.

The purpose of CAAC is to provide independent and objective advice to the HSE on applications for consultants, and qualifications for consultant posts.

CAAC provides a significant opportunity for consultants to contribute their expertise and professional knowledge to the decision-making process for the development of consultant services throughout the country. It provides input from many parts of the Health Service, including Clinical Programme Leads who have a substantial input into the strategic direction of CAAC approvals.

- **CAAC membership¹**

There were a number of changes to the CAAC membership during 2022.

- Professor Trevor Duffy, Director of Healthcare Leadership (replacing Dr Catherine Fleming) joined at the beginning of 2022.
- Mr Mick Molloy joined as an Irish Medical Organisation representative at the beginning of 2022 in place of Dr Clive Kilgallen, who stepped down from the CAAC in December 2021.
- Dr Nóirín Russell joined the Committee as the representative from the Institute of Obstetricians & Gynaecologists in September 2022, replacing Dr Cliona Murphy.
- Ms Rachel Morrogh (Irish Cancer Society) and Ms Roisin O’Leary (Sage Advocacy) joined in June 2022, serving as representatives of Patient Advocacy / Public Interest.
- Ms Lucy Nugent, CEO of Tallaght University Hospital, replaced Ms Sandra Daly as the Voluntary Hospitals representative in November 2022.

CAAC would like to thank all members for their valued contributions over the course of their membership.

2. CAAC Meetings



- **Applications considered at CAAC**


² A replacement post refers to an approved post which has been become, or is due to become, vacant and approval is being sought to refill. Note where a restructure is being undertaken at the time of replacement due to service requirements this is considered a replacement post

³ A restructure post refers to a currently occupied approved post where changes are being proposed to the structure of the post.

3. Posts Recommended for Approval


Figure 1 – Number of Posts Recommended for Approval 2021 and 2022

There was a slight decrease (11%) in the number of posts recommended for approval at CAAC when compared to 2021 as shown in Figure 1 below.

Breakdown of posts approved per specialty

Further analysis of approvals shows which specialties posts were approved in with the largest number of posts approved in the discipline of general medicine (n=110) with 79 new posts, 19 replacement and 12 restructure posts. Figure 2 below sets out the details of posts approved for each specialty. These figures do not include Change of Contract approvals.

Figure 2 – Breakdown of posts approved per specialty




A Letter of Approval (LoA) is issued by National Director of Human Resources on foot of recommendations received with regard to applications considered and recommended by CAAC. Letters of Approval were issued for all posts recommended for approval by CAAC during 2022. In 2022 503 Letters of Approval were issued.

Following the December 2022 CAAC Meeting there were 5 applications which were recommended for approval subject to clarification on queries. These posts are awaiting issue of a Letter of Approval pending clarification on queries raised.

As of 31st December 2022 there was 1 post deferred. This will be brought back to the CAAC for consideration when queries raised have been addressed. Figure 3 shows a comparison of number of Letters of Approval issued in 2021 and 2022.

4. Consultant Establishment in Republic of Ireland

On 31 December 2022, there were 4,190 approved⁴ Consultant posts representing an increase of approximately 9% when compared to 31 December 2021, when there were 3,847 approved Consultant posts.

This is an overall increase of 2,243 in approved Consultant posts since the introduction of the HSE in 2004.

Table 1 below shows the trend in approved consultant post numbers since 2004 per specialty. This table includes data from 2004 which was when Comhairle was replaced by HSE to approve Consultant posts, 2010 which reflects the commencement of data collation and 2018 onwards which is the date from which DIME data is being used.



⁵ Public Health – Introduction of new grade of Consultant in Public Health Medicine for the implementation of new model for Public Health. Under the Health Act 2004 the HSE has specific statutory functions in relation to the regulation of the number and type of Consultants employed in the health system. The HSE has put in place, on an interim basis subject to legislative amendment, a process which mirrors the steps involved in the standard consultant approval process for Consultants in Public Health Medicine. The Consultant Establishment Table therefore reflects the total number of Approved Consultant posts in the public health system.

5. Amendments to Medical Qualifications

All qualifications specified by the HSE for consultant posts require that consultants are registered as a specialist in their relevant specialty on the Specialist Division of the Register of Medical Practitioners maintained by the Irish Medical Council.

A schedule of the qualifications applicable to the different types of consultant posts is held by CAAC, and can be accessed on the HSE National Doctors Training & Planning (NDTP) website by clicking [here](#). Any amendments or additions to this list must be submitted to and approved by CAAC.

During 2022 the following requests for changes to titles / qualifications were received and consultation with the relevant stakeholders commenced.

1. Consultant Physician with a special interest in stroke medicine – consultation ongoing.
2. Consultant Neonatologist – this qualification was added as follows

4.16 Consultant Neonatologist (updated Dec 2022)

Registration as a specialist in the Specialist Division of the Register of Medical Practitioners maintained by the Medical Council in Ireland in the specialty of Neonatology

OR

(a) Registration as a specialist in the Specialist Division of the Register of Medical Practitioners maintained by the Medical Council in Ireland in the specialty of Paediatrics
and

(b) Two years certified postgraduate training in neonatology.

6. CAP (Consultant Applications Portal) Module

All applications for new, replacement and restructures for consultant posts are submitted online via the CAP.

The introduction of CAP in 2018, has resulted in greater overall transparency with regards to the application submission and approval process as well as greatly reducing processing time. In 2022, 58% of applications submitted were processed within 4 weeks of receipt.

2022 saw further completed work around plans to enhance the existing CAP Module within DIME. The aim is to automate further manual elements and to extend access to relevant Stakeholders, including CAAC. Implementation of the enhancement is planned for 2023.

CAAC Recommendation	Explanation
RFA	when an application has been considered and discussed at CAAC and is recommended for approval
RFA subject to	when an application has been considered and discussed at CAAC and is recommended for approval subject to a request for additional information which must be forwarded to NDTP prior to any letter of approval being issued
Deferred	when an application has been discussed at CAAC and a decision has been made to defer consideration. The CHO/HG will withdraw the application until such a time that it is appropriate to re-initiate the application with additional information
Rejected	when an application has been considered and discussed at CAAC and is not recommended for approval
Withdrawn	when an application has been considered and discussed at CAAC and is subsequently withdrawn by the CHO/HG

Application Type	Explanation
New	a post which has not been previously approved and is a new role or an additional post for an established department
Replacement	an approved post which has been become or is due to become vacant and approval is being sought to refill
Restructure	an approved post where changes are being proposed to the structure of the post – e.g. working hours, location of post
Change in Contract	an application submitted by the site on behalf of the consultant where they wish to change their contract from one contract type to another (excluding Type C as these applications are considered separately by the Type C Committee)
