Spread the word to NCHDs

Medical Careers Day, a joint initiative between NDTP, the Forum of Irish Postgraduate training and the Irish Medical Council is taking place on Saturday, **September 10th 2016** in Royal Hospital Kilmainham. In attendance will be representatives of Postgraduate training bodies along with current specialty trainees. This provides a unique opportunity for career guidance and networking for interns along with medical students (final year and penultimate year). A CV workshop will be held during the day. National Employment Record (NER), introduced in 2015 has great potential to make our move between jobs easier. Prior employers have 60days after we leave their hospital to upload any outstanding relevant documents so I suggest that NCHDs ensure that their NER documents are up-to-date and if not, contact previous Medical HR departments directly.

I also want to remind people to upload any recent training certificates received from induction... so as to make next job move that little bit easier.

Continuous Professional Development – Support Scheme (CPD-SS)

Please alert NCHDs in non training posts that the Continuous Professional Development Support Scheme is open for enrolment.

The CPD—SS is funded by the HSE to facilitate NCHDs who are not in training posts to continue to maintain and enhance their clinical knowledge and skills and also to maintain their professional competence in line with Medical Council requirements.
