Please find the attached safety notice received at Primary Care Reimbursement Service regarding the possible circulation of counterfeit Prime and Bond NT refill bottles.

Since the attached notice was issued, product which match the given batch numbers have been found in Ireland.

Additional suspect product has been found which does not match the batch numbers but has the physical identifiers on the labelling which matches that being circulated in the HPRA safety notice.

Can you please examine the stock currently used within your premises in an effort to ensure they do not correspond to the counterfeit stock as outlined in the attached notice.

#### **ISSUE**

The HPRA has become aware that counterfeit Prime & Bond NT Refill bottles have been placed on the European market. There is no evidence that the counterfeit products have been sold in Ireland. This notice is to alert users to examine their stock for the above counterfeit lot numbers, quarantine, where necessary and to check future stock for further possible counterfeit items.

#### **ACTION OR RECOMMENDATIONS**

HPRA advises users of the following:

Check current stock and previous purchasing records for the counterfeit lot numbers **1511000479** (expiring 2018-11) and 1304000648 (expiring 2017-12). If identified, do not use any remaining stock and quarantine immediately as it is not genuine product.

- Where procedures have been completed with a counterfeit lot, there is a risk the filling will de-bond and appropriate corrective action should be taken.




#### **ADDITIONAL INFORMATION**

In addition to the confirmed counterfeit lot numbers identified above, the following images provide a visible comparison of the main differences between the genuine and the counterfeit product.

1. The front view of the outer carton of the counterfeit product displays an additional flammable symbol.



2. The side view of the outer carton of the counterfeit product displays an additional 'patent pending' label.



3. The opposite side view of the outer carton of the counterfeit product is missing the CE mark beside the manufactures details.

4. The bottle label of counterfeit product displays the CE mark in the incorrect location and an additional flammable symbol.
