COVID-19 Vaccination in children aged 6 months - 4 years

Dear Doctor,

In line with NIAC guidance, the HSE is now commencing COVID-19 vaccination for children aged 6 months to 4 years. Comirnaty 3 micrograms/dose is currently the only vaccine approved and licensed by the EMA for this age group. Administration of the adult formulation at a reduced dose is not licensed and must not be given to children aged 6 months – 4 years.

COVID-19 vaccination is recommended for those with underlying conditions that place them at higher risk of severe COVID-19. COVID-19 vaccination is also being offered to all others in this age group.

The recommended vaccine schedule is three doses with an interval of 3 weeks between dose one and two and at least 8 weeks between dose two and three.

The roll out of vaccines to children aged 6 months-4 years will be in line with existing processes for children aged 5-11 years, so they will only receive their COVID-19 vaccine at a vaccination centre. Appointments will be available commencing 20th February 2023. Children in this age group cannot be vaccinated in general practice or at a pharmacy.

NIAC advise that priority should be given to the routine childhood immunisation schedule. Until there is more evidence it is prudent to separate COVID-19 vaccination in children aged 6 months-4 years from other vaccines for a period of 14 days.
