Seasonal Vaccination Programme Update

Dear Doctor,

Thank you for your participation in the autumn / winter vaccination programme for COVID-19 and influenza which is well underway, to-date over 290,000 COVID-19 boosters and almost 665,000 flu vaccines have been administered by General Practices.

Recording Vaccines

It is essential that all vaccines given are recorded promptly onto the IT systems, so that clinical records are kept up-to-date. Please ensure the patient vaccination records are entered into your GP Practice Management System or GPVax at the time of vaccination. Please check your LAIV vaccine expiry dates, and note that earlier deliveries of LAIV have an expiry date of 9th December 2025.

Removal of COVID-19 vaccine types

In order to ensure the vaccine types and batches on the GP IT systems are up-to-date, we periodically remove vaccine products which are no longer in use. This supports improved workflow and reduces the COVID-19 vaccine products on the systems.

The following COVID-19 product is no longer in use and will be removed from GP IT Systems effective from **1st April 2026**

- Comirnaty KP.2 COVID-19 mRNA Vaccine

Any outstanding vaccine records and claims relating to the above product must be entered by **5pm on 31st March 2026** as it will not be possible to submit after this date.

Any expired vaccine stock should be returned to NCCS using the normal process with your next delivery – see <https://www.hse.ie/eng/health/immunisation/hcpinfo/vaccineordering/vaccreturn.pdf>


NCCS Annual Stocktake

The annual stocktake of all HSE vaccines must be completed by 31st December 2025. This is required to comply with Comptroller & Auditor General regulations and each vaccine must be recorded. Please log on to the National Cold Chain portal and complete your stocktake returns at www.ordervaccines.ie, even if you are not placing any new orders. If you do not have any vaccine stock, please submit your stocktake entry with a Zero quantity. Please check stock and remove all expired vaccines immediately in preparation for return to NCCS.

No orders for January 2026 can be processed until the NCCS online stocktake has been submitted.
