RE: Temporary Supports for GPs- Winter Pressures: Submitting Claims and Grant Payments (Extended Day / Evening)

Dear Doctor,

I refer to Circular Number: NCO-23-2022, dated 23rd December 2022, issued to all GPs via GP Application Suite.

With regards to GP Winter Pressure Support Grant Payments (Extended Day/ Evening), all participating GMS GP practices (single handed and group) are requested to complete the attached Application Form in full and submit to gp.agreement@hse.ie by 28th February 2023. On receipt and verification of the form arrangement will be made for payment of the grant element of this initiative though PCRS.

Please note, in the case of a Group GMS GP practice, one nominated GMS GP should complete **one application form** on behalf of all GMS GPs in their practice. Identifying each GMS GP in the practice will facilitate processing of individual grant payments, where applicable. GMS GP Practices who submit their application form after this closing date, and are eligible for a grant, may experience delays in receiving the relevant payments.

As outlined in the previous memo, the Winter Pressure - Extended Day/ Evening period will cease on Friday 3rd February 2023. In this regard, I wish to advise that there is a requirement for all GP Winter Pressure Extended Day/ Evening Claims to be submitted electronically to PCRS by **COB 14**th **February 2023.** For GPs who plan to submit their Winter Pressure claims manually, the closing date for these submissions is also **COB 14**th **February 2023.**

I wish to take this opportunity to convey the HSE's appreciation to the GPs and their practice staff who provided these additional temporary supports during the recent challenging winter period.
