Re: Procedures for submission of Extemporaneous Preparations

Dear Pharmacist,

As notified to you, the Health Professionals (Reduction of Payments to Community Pharmacy Contractors) Regulations, S.I. 246 of 2009, was signed into law by the Minister for Health & Children with the consent of the Minister for Finance on the 1st of July 2009.

The Regulations set out the fee rates applicable in respect of Extemporaneous Preparations. To assist pharmacists and to expidite reimbursement in respect of such claims the following administrative arrangements are being introduced with effect from 1st November 2009.

General Medical Services Scheme Extemporaneous Preparations

For GMS extemporaneous preparations electronically submitted; the relevant code (see attached list) should be transmitted along with a description of the preparation, formula used, the quantity dispensed and the ingredient cost as per the Regulations. The new claiming code will trigger the relevant extemporaneous fee and VAT amounts where applicable. A similar procedure will apply in respect of manual claims, however, the formula used, quantity dispensed and ingredient cost must also be detailed on the GMS prescription.

Community Drug Schemes Extemporaneous Preparations

For DPS/LTI/HAA extemporaneous preparations electronically submitted; the relevant code (see attached list) should be transmitted along with a description of the preparation, formula used, the quantity dispensed and the ingredient cost as per the Regulations. The new claiming code will trigger the relevant extemporaneous fee, mark-up and VAT amounts where applicable. A similar procedure will apply in respect of manual claims under the DPS/LTI/HAA/EEA, however, the description of the item, formula used, the quantity dispensed and the ingredient cost must also be detailed on the claim form. DPS/EEA Extemporaneous reimbursable preparations are the same as those applicable to the GMS Scheme.
