Subject: Current status of supply of liquid preparations of antibiotics

Dear Colleagues,

You will be aware of recent concerns about antibiotic supply. There has been an increased demand for antibiotics over the holiday period. The work and support of GPs and Pharmacists during this challenging time is acknowledged.

The following is an update on the supply of liquid preparations of antibiotics.

Phenoxymethylpenicillin

- Kopen[™] both liquid preparations out of stock with no expected date of re-supply
- Calvepen[™] suspension out of stock, potential re-supply in late January

Cefalexin

- 125mg/5ml Supply currently available
- 250mg/5ml Shortage notified due to unexpected increase in demand, resupply expected in April

Amoxicillin

125mg/5ml & 250mg/5ml - Limited stock at wholesale level. Resupply expected in February

Clarithromycin

- 125mg/5ml Supply currently available
- 250mg/5ml Shortage due to unexpected increase in demand, re-supply expected in mid-January□

Co-amoxiclav

- 400 mg/57 mg/5 ml powder for oral suspension (35ml unit) Shortage notified
- 400 mg/57 mg/5 ml powder for oral suspension (70ml unit) Supply currently available
- 125mg/31.25mg powder for oral suspension Supply currently available

Flucloxacillin

· Supply currently available.

For prescribers:

Rounding doses

As liquid formulation may be unavailable, consider rounding doses to the nearest capsule/tablet strength to facilitate administration of capsule/tablets. Liaising with community Pharmacy

If a patient is being prescribed antibiotics, please ensure a supply is available in the community pharmacy.

Prescribing alternatives

It may be necessary to prescribe an alternative antibiotic if supply of the first line agent is not possible. This can be done by specifying an alternative antibiotic to the first line choice when sending the prescription to the pharmacist. Alternative first line agents can be found on www.antibioticprescribing.ie

Duration of treatment

With added demands on limited antibiotic stock, please keep antibiotic prescriptions to the recommended duration.

For children with uncomplicated bacterial infections being sent home on antibiotics (without requiring admission) please refer to the HSE community antibiotic guidelines for advice on antibiotic choice and duration: www.antibioticprescribing.ie

For **pharmacists**:

Pharmacy teams are experiencing temporary and intermittent interruption of supply of relevant antibiotics due to surge in demand. Marketing authorisation holders and wholesalers may have implemented allocations to ensure equitable distribution of the medicines.

Please be aware that in some cases, the products may appear as unavailable on their ordering system but additional stock above an allocation may be accessed by contacting the wholesaler or marketing authorisation holder.
