Details of the application of the increase to allowances in the nature of pay are also provided - those not included will issue under separate cover.

Agencies are reminded that no offers or commitments whatever can be made at any stage with regard to special increases, or for improvements or in conditions of employment of any grade, group or individual, without prior consultation with the Department.

Your 1998 allocation will be adjusted, on the basis of figures already agreed with the Finance Unit, to take account of the cost of the increase from 1 July 1998. Details of the actual cost of implementation should be incorporated into Appendix 1 and returned to the Department's Finance Unit.
