Revision of Remuneration Under the Partnership 2000 for Inclusion, Employment and Competitiveness

I am directed by the Minister for Health and Children to refer to the Annex to the Agreement on Pay and Conditions of Employment between the Irish Congress of Trade Unions and Employers Organisations which forms part of Partnership 2000 for Inclusion, Employment and Competitiveness.

In accordance with Clause 3 of the Annex, sanction is hereby given for the implementation of Phase III of the Agreement i.e. an increase of 1.5% of basic weekly pay with effect from 1 July 1999. It should be noted that it is in order to apply this increase to pensioners. Full details of the revised pay scales are provided in the Consolidated Salary Scales booklet. Details of the application of the increase to allowances in the nature of pay are also provided - those not included will issue under separate cover.

This circular does not convey sanction of local bargaining increases. Partnership 2000 entitles trade unions to claim adjustments in pay and/or conditions of employment the cost of which shall not exceed 2% of this basic pay cost of the particular grade, group or category of employee. These are conditional upon there having been verified progress to a satisfactory level on implementation of the modernisation programme set out in Chapter 10 of the Partnership. As discussions are not yet finalised, instructions in relation to such adjustments will issue at a later stage.

Agencies are reminded that Partnership 2000 precludes cost-increasing claims by trade unions or employees for improvements in pay or conditions of employment other than in relation to certain pension and sick pay elements. Any other increases in direct or indirect pay costs must be accommodated within your existing budget.

Your 1999 allocation will be adjusted, on the basis of figures already agreed with the Finance Unit, to take account of the cost of the increase from 1 July 1999. Details of the actual cost of implementation should be incorporated into Appendix 1 and returned to the Department's Finance Unit.
