Dear Colleagues,

I refer to the provisions of Labour Court Recommendations No. LC22066 which are in relation to the implementation of Phase IV of the Job Evaluation process for Support Staff. The evaluations took place between 2020 and 2022.

This Circular gives effect to the outcomes in respect of the upgrading of support staff to higher bands within the support staff structure. The revised bands applicable as per Phase IV are set out below.

The effective date of application is <u>1<sup>st</sup> January 2021</u>.

Individual existing increment dates will remain in place. Where an employee has been on the max of the scale and therefore does not have an increment, previous date of increment applies.

The higher rebanded rates applying to grades encompassed by this circular, are applicable to pension benefit calculations for retirements with effect from 1<sup>st</sup> January 2021 only.

As a general matter of note, the exercise of Job Evaluation has revealed that some employees may be sitting in grade codes that are not reflective of the role and function which they are carrying out. Local management should review and ensure that all employees are grade coded in accordance with their role and duties, and in line with the consolidated salary scales.
