Re: Audiological Scientists

The Labour Court in LCR 16573 in respect of Audiological Scientists, then employed in National Rehabilitation Board, recommended the undertaking of an evaluation of the value of the posts being carried out by the staff concerned. Following completion of the evaluation process, and subsequent to further submissions by both parties to the Labour Court, the Court recommended that all future appointments to basic or senior Audiological Scientists posts should be paid at the rate of basic or senior physicists scale. In respect of the senior post, the Court recommended that the parties commence early discussions to agree a job profile for the post. Discussions in respect of this element of the recommendation remain to be completed.

Accordingly, any staff recruited to a post of Audiological Scientist should be paid on the basic grade Physicist salary scale. The current rate of pay applicable to this grade is:

Any staff recruited to a post of Senior Audiological Scientist should be paid on the Senior Physicist salary scale. The current rate of pay applicable to this grade is:

Please note that any such recruitment should await the outcome of the discussions in respect of job description referred to in the opening paragraph.

In respect of the above small group of staff who were in the employment of the National Rehabilitation Board in April 2000, the Court recommends that these staff be paid on the Senior Physicist salary scale. The Court further recommends that this arrangement should apply from 14th April 2000 and that the method of assimilation should be on the basis of the nearest point not below existing pay, plus one increment. It should be noted that the staff concerned were heretofore paid on the teacher's common salary scale with appropriate extra allowances for additional qualifications held. The Court states that the assimilation arrangements should take account of such qualifications allowances.
