Re: Establishment of the post of Chief Audiologist under the terms of the Expert Group on Various Health Professions

I am directed by the Minister for Health and Children to refer to the recommendations of the Expert Group on Various Health Professions, in relation to the establishment, in each E.N.T./Hospital Audiology department, of the post of Chief Audiologist.

Sanction is given the creation of these posts with effect from 1 April 2000.

The pay scale with effect from 1 April 2000 was

24,092 24,942 25,792 26,642 27,492 28,342 and, with effect from 1 October 2000 is 25,417 26,314 27,211 28,107 29,004 29,901

As proposed by the Expert Group, the following are the criteria to be applied when creating the post of Chief Audiologist:

Applicants should:

- have at least five years clinical diagnostic experience
- have a qualification [BAAT 1,2 and in the furture MSc]
- be performing in their Department the full range of diagnostic assessments.

In order that your non-capital allocation may be adjusted to take account of the costs involved, you are asked to complete costing forms (Appendices I & II) to reflect the funding required. Please complete and return these forms to Personnel Management and Development Unit as soon as possible.
