## **Dear Colleagues**

I wish to advise that the Department of Health has issued **Circular 2/2023** Application 1 February 2022 pay adjustments for certain Dental grades only in the Medical/Dental Sectoral Bargaining Unit (**Appendix 1**).

Building Momentum – Public Service Agreement 2021-2022 provided for the equivalent of a 1% increase in annualised basic salaries to be used as a Sectoral Bargaining Fund or a general pay round increase on 1 February 2022. The sanction set out in **Department of Health Circular 2/2023** specifically applies to the retrospective application of 1 February 2022 pay adjustments in relation to a select number of Dental grades only, who are part of the Medical/Dental Sectoral Bargaining Unit in the Public Health Sector that have not previously been agreed. Within the terms of the Sectoral Bargaining fund available for this Bargaining Unit,

relevant unions have opted to use the fund as a general round increase of 1% to the specific dental grades.

## The specific dental grades impacted are listed in the Department of Health Circular 2/2023 and the salary scales that apply to these grades are set out in the Appendix to the Department of Health circular (Appendix 1).

In line with 2.7 of the WRC Review of Building Momentum, the adjustments will be implemented at the earliest possible date with retrospective effect to <u>1 February</u> <u>2022</u> (or date of appointment, if later), unless there are exceptional circumstances in the settlement arrangements whereby retrospection would not be appropriate.

The circular also set out the arrangements in respect of pensions, overtime, premium payments and allowances.

Please ensure that this Circular is brought to the attention of all relevant managers in your area of responsibility including relevant hr managers, payroll and staff of your organisation as appropriate.
