The Department of Health have advised that they have amended figures for the salary scale of grade code 359T **E.C.G Technician (With formal qualification)** in the 01/01/2019 Consolidated Salary Scales

The 1% increase awarded to all annualised salaries on 1/10/2018 was omitted for this grade, resulting in the 1% increase applied to salaries under €30,000 for the first three points of this scale being incorrectly adjusted for 1/1/19 salary scales.
