Dear Colleagues

I wish to advise that the Department of Health has issued Circular 3/2023 Application of pay adjustments for 1 March 2023 (Appendix 1) which should be read in conjunction with Department of Public Expenditure and Reform (DPER) Circular 02/2023 Application of 1st March 2023 pay adjustments (Appendix 2). A copy of the new Department of Health Consolidated Salary Scales with the revised pay scales for affected grades is attached in Appendix 3.

This circular gives effect to section 3.1 of the Building Momentum – Public Service Agreement 2021-2023 which provides that the annualised amount of the basic salary of public health sector staff will be increased by 2% with effect from 1 March 2023.

Department of Health Circular 3/2023 also sets out arrangements in respect of overtime, premium payments rates of pay, allowances, pensions and other amendments to specific grades which reflected in the current consolidated salary scales.

Please ensure that this Circular is brought to the attention of all relevant managers in your area of responsibility including relevant hr managers, payroll and staff of your organisation as appropriate.
