Allowances payable to Radiographers employed in Breastcheck, National Screening Service

Dear Rosarii,

Outlined below are details of allowances payable to radiographers employed in Breastcheck, National Screening Service, as sanctioned by the Minister for Health.

### **Annual Allowance**

An annual allowance of €4,492 is payable to radiographers in respect of

- their agreement to flexibility in provision and location of screening services to facilitate maximum uptake
- · their responsibilities in relation to mobile units and
- their commitment to the rigorous auditing and performance review

This allowance was sanctioned in 1999 and remains in place. To date, this allowance has not been included in the Consolidated Salary Scales, however this will now be rectified. This allowance is reckonable for pension purposes.

# **Quarterly Allowance**

A quarterly allowance of €1,500 is payable to radiographers in respect of

- additional attendance of 6 hours a week in excess of standard working week to attend out of hours meetings
- clinical activities including assessment clinics running late and
- availability for wire-gulded localisation procedures etc.

This allowance ceased in 2010 for new entrants, however as per the provisions of the Public Service and Stability Agreement (PSSA) 2018 – 2020, this quarterly allowance has been restored for new entrants. The effective date of restoration is 1 January 2018. This allowance is reckonable for pension purposes.

This circular should be brought to the attention of all HR/Payroll personnel and radiographers working in Breastcheck.
