Re: HR Circular 020/2018 re Application of 1 October 2018 Pay Adjustments under the Public Service Pay and Pensions Act 2017

Dear Colleagues,

I wish to advise that the Department of Health have issued Circular 13/2018 (attached as **Appendix 1**). The Circular sets out the pay adjustments due on **1 October 2018** as provided for in the Public Service Pay and Pensions Act 2017 and in accordance with the pay increase agreed in the Public Service Stability Agreement (PSSA 2018 – 2020).

In accordance with Section 7(1) of the Public Service Pay and Pensions Act, the annualised amount of the basic salary of public health sector employees will be increased by 1% with effect from the 1 October 2018. Public health sector employees who have not yet achieved full restoration of the pay adjustment under the FEMPI Act 2013 will have the 1% increase due on the 1 October 2018 calculated in accordance with Section 18 of the Public Service Pay and Pensions Act 2018. **Appendix 2** attaches the previously issued DPER guidance note dated 21 December 2017 which addresses these salary adjustments (See Part 1, Paragraph 12).

The revised Consolidated Salary Scales for **1 October 2018** are set out in **Appendix 3**.

Please ensure this Circular is brought to the attention of all relevant personnel including Payroll Managers.
