Health Service: Implementation of the Independent Hours Body Recommendations in relation to the Haddington Road Agreement

(HRA) Hours.

## Dear Colleagues,

The Department of Health have issued Circular 02/2022 to address the Government's decision to restore pre-Haddington Road weekly working hours. The provisions of this Circular apply to public health sector employees who were impacted by the HRA additional hours requirement.

Additional HRA hours implemented in 2013 reverted for impacted public health sector employees with effect from 1 July 2022. This is subject to a minimum working week of 35 hours for fulltime health service employees.

## • FAQs HRA Hours v14.0:

This Frequently Asked Questions (FAQ) document is associated with the restoration of pre-HRA weekly hours for guidance and assistance, and addresses the implementation of the pre-HRA restoration in the HSE and Section 38 employers. Employers should also consult previously circulated *Haddington Road Agreement Reduction in hours of work 'Principles'* document Version 2, and HSE HR Memo of 23<sup>rd</sup> of June 2022 *Reversal of Haddington Road Agreement* (HRA).

Employers are required to ensure implementation as of 1st of July 2022.
