Subject: HR Circular 036/2019: Sexual Assault Treatment Unit (Standardisation of Out of Hours Arrangements) Forensic Nurse Examiners

Dear Colleagues,

Following the conclusion of conciliation discussions under the auspices of the Workplace Relations Commission, the following standardised arrangements in respect of Forensic Nurse Examiners involved in the provision of "On Call Arrangements" now stand to be implemented in relevant locations. These services are currently provided in SIVUH, Letterkenny, UCHG, Waterford, Mullingar and Rotunda Hospital.

1. These standardised arrangements will apply from 1st July 2019.

2. On call payments

| Mon – Fri | 44.57 |
|---------------------|-------|
| Saturday | 57.24 |
| Sun/Public Holidays | 77.38 |

- Call out duration up to 4 hours per case hourly rate to apply thereafter.
- a. All these figures (on call) are based on a 12 hour period. Pro rata to apply after 12 hours.
- b. In exceptional circumstances where a person not "on call" is required to attend a SATU, that individual will be remunerated on a fee per case basis. (€178.28). If such a person's advice is solely provided over the phone, a pro rata payment equating to the period of the time involved will be made.

This agreement will also apply to circumstances where such advice is given by a person "on call" but not required to physically attend the SATU.

3. Call Out Fee/Payments

| Mon – Fri | 178.28 |

| Saturday | 178.28 |
| Sun/Public Holidays | 178.28 |

- a) These rates apply in respect of call out durations of up to 4 hours, hourly rate to apply thereafter.
- b) The call out fee (178.28) will apply from time of receipt of call regarding the case.

4. Time off in Lieu

TOIL will be applied in accordance with general HSE arrangements

5. Sleep time/Compensatory Rest

Will be applied as per general HSE arrangements i.e. staff up between 12 and 2am will get the half day the next day and staff up after 2am will receive the next day off.

6. Travel

Travel will be paid in accordance with agreed HSE rates.

7. Loss of Earnings

Where the introduction of the new arrangements results in a loss of earnings for any individual after a period of twelve (12) months application, the established arrangements for loss of earnings, provided for under the Public Service Stability Agreement (PSSA) will apply.

8. Once off Additional Leave

On an exceptional basis and as a gesture of goodwill an additional three (3) days annual leave to be taken by claimants not later than 31st December 2021. Such additional leave arrangement will be made in full contemplation of the exigencies of SATU services.

9. Local issues

The INMO identified several circumstances where local anomalies exist with application of the general HSE on call arrangements. These issues will be addressed by direct engagement between the INMO and the HSE locally.

10. Review

The practical operation of this agreement will be jointly reviewed by the parties not earlier than October 1st 2020.
