Working From Home during COVID-19

Dear Colleagues

Please find attached a copy of the **HSE Policy on Public Health Service Employees Working from Home during COVID-19**. This Policy applies to all employees in the HSE and Section 38 organisations who are required to work from home on a temporary basis during COVID-19. The Policy is based on the Department of Public Expenditure and Reform's guidance document for Civil Service Organisations: *Working from Home during COVID-19*.

The purpose of this Policy is to support the health and wellbeing of health service employees who are working from home during COVID-19; to ensure effective performance management and employee engagement; to ensure that good practice is followed by all employees when working from home; and to support the effective delivery of high quality services.

It is important to note that that any remote/home-based working arrangements that have been implemented due to COVID-19 are temporary and apply to the COVID-19 period only.

Please ensure that this Policy is brought to the attention of managers and relevant staff within your area of responsibility and that temporary remote working arrangements during COVID-19 are kept under review.
