Re: Payment of Arbitration Award to Consultants in Emergency Medicine

Dear Colleague

I refer to previous correspondence from Andrew Condon, General Manager, Consultant Contract Implementation regarding payment of the arbitration award to Consultants in Emergency Medicine.

I note that Consultants were paid 85% of the award in line with the attached template prior to 31st December 2008. On 9th February 2009 Mr Condon notified Hospital Network Managers that HSE and HSE-funded agencies should take the steps necessary to:

- a) pay the outstanding 15% of the arbitration award;
- b) ensure those Consultants in Emergency Medicine who have remained on Consultant Contract 1997 and hold a Category I Contract are now paid at the higher Category I rate;
- c) pay any monies outstanding to Consultants in Emergency Medicine who have remained on Consultant Contract 1997 and hold a Category I Contract on the basis that they were eligible for payment at the higher Category I rate from 1st June 2008 onwards.

In addition, Mr Condon noted that claims for payments related to rest days etc. will be examined at a later date on a case by case basis as agreed with the IHCA.

Taking this into account, arrangements should now be made to:

- Complete the implementation of the measures listed at a) to c) above immediately;
- Locum or temporary Consultants employed between 1st January 1998 and 31st May 2008 on the Consultant Contract 1997 who make claims relating to the arbitration award should be paid in the same manner as permanent Consultants;
- Obtain from Consultants in Emergency Medicine details of claims relating to untaken rest days and other payments calculated on a daily or sessional basis. Payment should be made in relation to such claims once validated by the employer;
- Calculate the extent to which payments made to Consultants who retired during the period in question may require adjustment.
